ORDER IN COUNCIL

At the Government House at Wellington this 29th day of May 1972

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Alcoholism and Drug Addiction Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

O R D E R

**1. Title and commencement**—(1) This order may be cited as the Alcoholism and Drug Addiction Institutions Order 1972.

(2) This order shall come into force on the 1st day of July 1972.

**2. Institution certified**—The institution to be known as The Bridge, comprising the several properties named and described in the Schedule hereto, is hereby certified as an institution under the Alcoholism and Drug Addiction Act 1966.

**3. Name of institution amended**—The Alcoholism and Drug Addiction Institutions Order 1969\* is hereby amended by omitting from the Schedule the words "Seacliff Hospital, Seacliff", and substituting the words "Cherry Farm Hospital, Waikouaiti".
