ORDER IN COUNCIL

At the Government Buildings at Wellington this 3rd day of April 1978

PURSUANT to section 5 of the Alcoholism and Drug Addiction Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Alcoholism and Drug Addiction Institutions Order 1978.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. Institutions certified—(1) The institution to be known as The Bridge, Auckland, comprising the several properties described in the First Schedule hereto, is hereby certified as an institution under the Alcoholism and Drug Addiction Act 1966.

(2) The institution to be known as The Bridge, Christchurch, comprising the several properties described in the Second Schedule hereto, is hereby certified as an institution under the Alcoholism and Drug Addiction Act 1966.

3. Name of institution amended—The Alcoholism and Drug Addiction Institutions Order 1972* is hereby amended by inserting in clause 2, after the words "The Bridge,", the word "Wellington".

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect. This order effects the certification under the Alcoholism and Drug Addiction Act 1966 of two institutions. One of these is to be known as The Bridge, Auckland. The other is to be known as The Bridge, Christchurch. The institution in Wellington which has until now been known as The Bridge

is renamed The Bridge, Wellington.
