ORDER IN COUNCIL

At the Government Buildings at Wellington this 8th day of November
1982

THE RIGHT HON. R. D. MULDOON PRESIDING IN COUNCIL

PURSUANT to section 5 of the Alcoholism and Drug Addiction Act 1966,
His Excellency the Governor-General, acting by and with the advice and
consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the
Alcoholism and Drug Addiction Institutions Order (No. 2) 1982.

(2) This order shall come into force on the day after the date of its
notification in the *Gazette*.

2. Institutions certified—(1) The institution known as the Bridge,
Auckland, comprising the several properties described in the First
Schedule hereto, is hereby certified as an institution under the Alcoholism
and Drug Addiction Act 1966.

(2) The institution known as the Nova Trust, Christchurch, comprising
the property described in the Second Schedule hereto, is hereby certified
as an institution under the Alcoholism and Drug Addiction Act 1966.

3. Revocations—(1) The warrant, dated the 15th day of December
1908* and made under section 37 of the Police Offences Act 1908,
authorising the institution known as “the Rotoroa Inebriates’ Institution”

to receive and detain habitual drunkards under the Police Offences Act 1908 (which institution is a certified institution under the Alcoholism and Drug Addiction Act 1966 by virtue of section 6 of the Reformatory Institutions Act 1909 and section 6 of the Alcoholism and Drug Addiction Act 1966) is hereby revoked.

(2) The Alcoholism and Drug Addiction Institutions Order 1978† is hereby amended by revoking both subclause (1) of clause 2 and the First Schedule.
