

# THE ACCIDENT COMPENSATION (PRESCRIBED AMOUNTS FOR CALCULATION AND PAYMENT OF LEVIES) ORDER 1984

### ORDER IN COUNCIL

At the Government Buildings at Wellington this 17th day of December 1984

#### Present:

THE HON. G. W. R. PALMER PRESIDING IN COUNCIL

PURSUANT to the Accident Compensation Act 1982, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### ORDER

- 1. Title and commencement—(1) This order may be cited as the Accident Compensation (Prescribed Amounts for Calculation and Payment of Levies) Order 1984.
  - (2) This order shall come into force on the 1st day of April 1985.
  - 2. Interpretation—In this order—

"The Act" means the Accident Compensation Act 1982:

"Corporation" means the Accident Compensation Corporation constituted under the Accident Compensation Act 1972:

"Full-time self-employed person" means a self-employed person who—
(a) On or after the 7th day of August 1984, is required to furnish under and for the purposes of the Income Tax Act 1976 a return of income derived by him in his financial year which corresponds with the income year that commenced on the 1st day of April 1983 or any succeeding income year; and

(b) Has worked as a self-employed person an average of not less

than 30 hours a week during that financial year.

- **3. Application**—This order shall apply for the purposes of the calculation and payment of levies by every self-employed person who is required by section 44 of the Act to deliver a statement of earnings as a self-employed person.
- 4. Prescribed amounts for the purposes of section 44 of the Act— For the purposes of section 44 of the Act,—

(a) In relation to every full-time self-employed person, the prescribed amount shall be \$5,200:

Provided that where any such full-time self-employed person has, in the manner and at the required time, being the 7th day of September 1985 or such later date as the Corporation may allow, so elected, the prescribed amount shall be \$14,768:

- (b) In relation to every other self-employed person, the prescribed amount shall be \$1,000.
- 5. Revocations—The following Orders in Council are hereby consequentially revoked:
- (a) The Accident Compensation (Prescribed Amounts for Calculation and Payment of Levies) Order (No. 2) 1981\*:
  - (b) The Accident Compensation (Prescribed Amounts for Calculation and Payment of Levies) Order 1982†:
  - (c) The Accident Compensation (Prescribed Amounts for Calculation and Payment of Levies) Order 1983‡.

## **EXPLANATORY NOTE**

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 April 1985, increases the prescribed minimum amount on which a full time self-employed person (as defined) pays the levy on his earnings as a self-employed person to \$5,200 or, if he so elects, \$14,768.
