PURSUANT to the Accident Compensation Act 1982, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Accident Compensation Employers and Self-Employed Persons Levies Order 1987, Amendment No. 2, and shall be read together with and deemed part of the Accident Compensation Employers and Self-Employed Persons Levies Order 1987* (hereinafter referred to as the principal order).

(2) This order shall come into force on the 1st day of April 1989.

2. Schedule—(1) The principal order is hereby amended by revoking the Schedule, and substituting the new Schedule set out in the Schedule to this order.

(2) The Accident Compensation Employers and Self-Employed Persons Levies Order 1987, Amendment No. 1 is hereby consequentially revoked.
