PURSUANT to the Accident Compensation Act 1982, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Accident Compensation Earners' Scheme Levies Order 1973, Amendment No. 4, and shall be read together with and deemed part of the Accident Compensation Earners' Scheme Levies Order 1973* (hereinafter referred to as the principal order).

(2) This order shall come into force on the 1st day of April 1984.

2. Classification of earners for levy purposes and rates of levy—

(1) Clause 4 (a) of the principal order (as amended by clause 4 of the Accident Compensation Earners' Scheme Levies Order 1973, Amendment No. 3), is hereby amended by omitting the expression "\$1.07", and substituting the expression "\$0.80".

(2) The principal order is hereby further amended by revoking the Schedule thereto (as substituted by clause 2 of the Accident Compensation Earners' Scheme Levies Order 1973, Amendment No. 2), and substituting the new Schedule set out in the Schedule to this order.
