**THE AGRICULTURAL CHEMICALS (INSECTICIDES) NOTICE  
1964, AMENDMENT NO. 2**

PURSUANT to regulation 3 (1) of the Agricultural Chemicals (Insecticides) Regulations 1964\* the Director-General of Agriculture hereby gives the following notice.

---

**NOTICE**

1. This notice may be cited as the Agricultural Chemicals (Insecticides) Notice 1964, Amendment No. 2, and shall be read together with and deemed part of the Agricultural Chemicals (Insecticides) Notice 1964† (hereinafter referred to as the principal notice).

2. For the purposes of the First Schedule to the principal notice (as substituted by this notice) the term "dairy cattle" means all cattle, including goats, that are reared or used for dairy purposes.

3. (1) The principal notice is hereby amended by revoking the First Schedule thereto, and the Second Schedule thereto (as amended by the Agricultural Chemicals (Insecticides) Notice 1964, Amendment No. 1‡) and substituting the Schedules contained in the Schedule to this notice.

(2) Clause 3 of the Agricultural Chemicals (Insecticides) Notice 1964, Amendment No. 1, is hereby revoked.

4. This notice shall come into force on the first day of May 1967.

SCHEDULES  
 "FIRST SCHEDULE"

Insecticide	Terms and Conditions
Pelleted preparations of finely ground DDT Granulated DDT/Super-phosphate	Not to be applied to— (a) Any pasture, unless and until all live-stock have been removed therefrom and are not returned thereto before the expiration of two weeks from the date of application of the insecticide: Provided that the insecticide shall not be applied to any pasture on which it is intended to graze dairy cattle, unless pursuant to a permit: (b) Any pasture on which cattle (other than dairy cattle) are to be grazed, where the height of the pasture is more than 3 in.: (c) Any pasture on which sheep are to be grazed, where the height of the pasture is more than 1 in.: (d) Any wet pasture: (e) Any pasture at a rate of application of active ingredient exceeding 2 lb per acre per annum: (f) More than one-third of the area of pasture on any land holding in any period of 12 months, unless and until a period of 12 weeks has expired since the date of the last application of DDT.

"SECOND SCHEDULE"

Any insecticide except the insecticides named in the Schedule to the Agricultural Chemicals (Insecticides) Regulations 1964\* (other than the formulations of DDT specified in the First Schedule to this notice)."
