ORDER IN COUNCIL

At the Government House at Wellington this 26th day of January 1976

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Agricultural Chemicals Act 1959, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Agricultural Chemicals Regulations 1968, Amendment No. 5, and shall be read together with and deemed part of the Agricultural Chemicals Regulations 1968* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Metric amendments—The principal regulations are hereby amended in the manner indicated in the Schedule to these regulations.
