THE ARMED FORCES ESTABLISHMENTS ROAD TRAFFIC BYLAWS 1970

PURSUANT to section 72 of the Transport Act 1962, the Minister of Defence, being the Minister having the control of the roads within the bounds of the Establishments specified in the First Schedule to these bylaws, hereby makes the following bylaws.

BYLAWS

1. Title and commencement—(1) These bylaws may be cited as the Armed Forces Establishments Road Traffic Bylaws 1970.

(2) These bylaws shall come into force on the date of their notification in the *Gazette*.

2. Interpretation—In these bylaws—

“Driver” includes the rider of a motor cycle or bicycle; and also includes the rider of a ridden animal; and “drive” has a corresponding meaning:

“Establishment” means any camp or station under the control of the Commanding Officer of any of the Establishments specified in the First Schedule to these bylaws.

3. Extent of bylaws—These bylaws shall apply with respect to all roads within the bounds of any of the Establishments specified in the First Schedule to these bylaws.

4. Persons to be authorised—No person shall drive any vehicle or ridden animal on any road within the bounds of any of the Establishments specified in the First Schedule to these bylaws unless he is authorised to do so under bylaw 5 of these bylaws.

5. Authorised persons—Subject to the provisions of these bylaws, the following persons and no others shall be entitled to drive any vehicle or ridden animal on any road within the bounds of any of the said Establishments, namely, drivers of the following descriptions of vehicles or ridden animals:

- (a) Vehicles or animals owned or operated by any of the armed forces or by members thereof:
- (b) Vehicles or animals owned or operated by bona fide visitors to messes or other recognised institutions in the Establishment:
- (c) Vehicles or animals owned or operated by any persons living within the bounds of the Establishment or by any bona fide visitors to those persons:
- (d) Vehicles or animals owned or operated by any Government Department, its employees, agents, contractors, and sub-contractors in the lawful exercise of any functions and duties connected with the Establishment:

- (e) Vehicles or animals owned or operated by any persons or firms and their employees, contractors, or subcontractors for the purpose of delivering or taking up merchandise, goods, and other supplies to or from shops, stores, and private living quarters and houses within the bounds of the Establishment:
- (f) Vehicles or animals owned or operated by persons in possession of a written authority to use the said roads by or by direction of the Commanding Officer of the Establishment.

6. Speed limits—(1) No person shall drive any vehicle or animal on the roads specified in the Second Schedule to these bylaws at speeds exceeding those specified in respect of those roads in the said Second Schedule.

(2) No person shall drive any vehicle or animal on any other road within the bounds of any such Establishment at a speed exceeding 30 miles per hour.

7. Parking of vehicles—(1) No person shall park any vehicle on any road within the bounds of any such Establishment in any place other than in a parking place approved as such by the Commanding Officer of the Establishment.

(2) For the purpose of this bylaw, the expression “park” means to stand a vehicle in any place within the bounds of any Establishment; but does not include the standing or leaving of a vehicle for any period not exceeding 5 minutes; and also does not include the standing of a vehicle in any place while actually engaged in taking up or setting down persons or goods.

8. Authority to stop and detain any vehicle or ridden animal—(1) Any officer or non-commissioned officer or security guard or warden in uniform is hereby authorised to stop and detain any vehicle or ridden animal within the bounds of the Establishment to which he for the time being belongs for the purpose of ascertaining whether the use of the vehicle or animal constitutes a breach of any of these bylaws.

(2) Every person commits an offence against these bylaws who, being the driver of any vehicle or animal within the bounds of any Establishment, fails to stop on the demand of any officer or non-commissioned officer or security guard or warden under this bylaw or in any way obstructs any such officer or non-commissioned officer or security guard or warden in the exercise of any of the powers conferred by this bylaw.

9. Authority to post or affix notices—The Commanding Officer of any of the said Establishments is hereby empowered from time to time to cause to be posted or affixed at the entrances to, and in any place or places within the Establishment, copies of these bylaws and other suitable notices or traffic signs sufficient to inform drivers of vehicles and animals of acts which constitute an offence under these bylaws.

10. Offences and penalty—(1) Every person who commits a breach of or fails to comply with any provision of these bylaws commits an offence against these bylaws.

(2) Every person who commits an offence against these bylaws is liable on summary conviction to a fine not exceeding \$40.

11. Bylaws to be subject to regulations—These bylaws shall, in relation to any Establishment to which Part IX of the Navy Regulations 1958* or the Air Force Areas Security Regulations 1967† apply, be read subject to the provisions of the said Part IX or those regulations, as the case may be.

12. Bylaws not to derogate from powers vested in Commanding Officers—Nothing in these bylaws shall derogate from the powers vested in the Commanding Officer of any of the said Establishments by virtue of his office to exclude persons from the Establishment or to regulate or restrict the movements of persons within the Establishment.

13. Revocations—The following bylaws are hereby revoked:
