



THE ADMIRALTY (FEES) ORDER 1988

ORDER IN COUNCIL

At Wellington this 7th day of March 1988

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 11 (4) of the Admiralty Act 1973, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Admiralty (Fees) Order 1988.

(2) This order shall come into force on the 11th day of April 1988.

2. Fees of Court—(1) The fee payable in respect of the filing of an application under rule 15 of the Admiralty Rules 1975* for the issue of a warrant of arrest shall be \$650.

(2) Subject to subclause (1) of this clause, the fees payable in respect of proceedings in the High Court in its Admiralty jurisdiction shall be those prescribed by the High Court Fees Regulations 1988†.

(3) The fees to be taken in respect of proceedings in a District Court in its Admiralty jurisdiction shall be those prescribed in the Third Schedule to the District Courts Rules 1948*.

3. Goods and services tax included—The fees prescribed by this order are inclusive of goods and services tax under the Goods and Services Tax Act 1985.

4. Revocations—(1) The Admiralty (Fees) Order 1987† is hereby revoked.

(2) The Fees Regulations 1987‡ are hereby consequentially amended by revoking so much of the Schedule as relates to the Admiralty (Fees) Order 1987.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 11 April 1988, prescribes the fees of Court to be taken in respect of proceedings in the High Court or in a District Court in its Admiralty jurisdiction.

A fee of \$650 is prescribed in respect of the filing of an application under rule 15 of the Admiralty Rules 1975 for the issue of a warrant of arrest.

The fees prescribed are inclusive of goods and services tax.
