## ORDER IN COUNCIL

At Wellington this 2nd day of September 1991

## Present:

THE RIGHT HON. J. B. BOLGER PRESIDING IN COUNCIL

PURSUANT to section 11 (4) of the Admiralty Act 1973, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

### ORDER

- 1. Title and commencement—(1) This order may be cited as the Admiralty (Fees) Order 1991.
  - (2) This order shall come into force on the 8th day of October 1991.
- 2. Fees of Court—(1) The fee payable in respect of the filing of an application under rule 15 of the Admiralty Rules 1975\* for the issue of a warrant of arrest shall be \$750.
- (2) The fee payable in respect of the filing under rule 23 of the Admiralty Rules 1975\* of a request for a commission for the appraisement and sale of any property shall be \$750.

\*S.R. 1975/85 Amendment No. 1: S.R. 1975/298 Amendment No. 2: S.R. 1987/170 (3) Subject to subclauses (1) and (2) of this clause, the fees payable in respect of proceedings in the High Court in its Admiralty jurisdiction shall be those prescribed by the High Court Fees Regulations 1991\*.

(4) The fees to be taken in respect of proceedings in a District Court in its Admiralty jurisdiction shall be those prescribed in the Third Schedule to

the District Courts Rules 1948†.

- **3. Goods and services tax included**—The fees prescribed by this order are inclusive of goods and services tax under the Goods and Services Tax Act 1985.
  - 4. Revocation—The Admiralty (Fees) Order 1989‡ is hereby revoked.
