**THE ANIMALS PROTECTION AND GAME REGULATIONS, 1930,
AMENDMENT NO. 3.**

Enacting authority : His Excellency the Governor-General in Council.
Act pursuant to which the regulations were made : The Animals
Protection and Game Act, 1921-22.

Date on which the regulations were made : 22nd day of March, 1937.

Date of notification in *Gazette* : 23rd day of March, 1937.

REGULATIONS.

1. These regulations may be cited as the Animals Protection and Game Regulations, 1930, Amendment No. 3.

2. These regulations shall be read together with and form part of the Animals Protection and Game Regulations, 1930* (hereinafter called "the principal regulations").

3. Clause (3) of Regulation 2 of the principal regulations as amended by Regulation 2 of the Animals Protection and Game Regulations, 1930, Amendment No. 2, is further amended by revoking the proviso thereto, and substituting the following :—

" Provided that in the Auckland, Bay of Islands, Hobson, Mangonui-Whangaroa, Whangarei, Rotorua, East Coast, Waiapu, Tauranga, Hawke's Bay, Feilding and District, and Wellington Acclimatization Districts licenses authorizing the holder thereof to take or kill both imported game and native game shall be in the form No. 1A in the Schedule hereto."

4. Clause (6) of the said Regulation 2 of the principal regulations as amended by Regulation 3 of the Animals Protection and Game Regulations, 1930, Amendment No. 2, is further amended by revoking the proviso thereto, and substituting the following :—

" Provided that in the Auckland, Bay of Islands, Hobson, Mangonui-Whangaroa, Whangarei, Rotorua, East Coast, Waiapu, Tauranga, Hawke's Bay, Feilding and District, and Wellington Acclimatization Districts the fee payable for a license to take or kill both imported game and native game shall be one pound five shillings (£1 5s.)."

5. The Schedule to the principal regulations as amended by Regulation 4 of the Animals Protection and Game Regulations, 1930, Amendment No. 2, is further amended by revoking form No. 1A, and substituting the following :—

[Form No. 1A.

LICENSE TO TAKE OR KILL IMPORTED GAME AND NATIVE GAME IN THE AUCKLAND, BAY OF ISLANDS, HOBSON, MANGONUI-WHANGAROA, WHANGAREI, ROTORUA, EAST COAST, WAIAPU, TAURANGA, HAWKE'S BAY, FEILDING AND DISTRICT, OR WELLINGTON ACCLIMATIZATION DISTRICT.

....., of, having this day paid the sum of one pound five shillings (£1 5s.) is hereby authorized to take or kill within the Acclimatization District of from the day of, 19.., to the day of, 19.. (both days inclusive), subject to the provisions of the Animals Protection and Game Act, 1921-22.

This license does not authorize the holder thereof to take or kill imported game or native game on lands actually and exclusively used by any registered acclimatization society for acclimatization purposes, or on any sanctuary or public domain, or on any land excepted from the operation of the notification declaring an open season for the district.
