ORDER IN COUNCIL

At the Government Buildings at Wellington this 21st day of June 1976

PURSUANT to the Animals Act 1967, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Animals Quarantine and Import Inspection Fees Regulations 1976.

 (2) These regulations shall come into force on the 1st day of July 1976.
- 2. Quarantine fees—(1) The fees prescribed by regulations 3, 4, and 5 hereof shall be payable for the transport, sustenance, care, testing, dipping, inspection, and other treatment of animals introduced into New Zealand on and after the 1st day of July 1976.
- (2) The regulations specified in regulation 6 hereof (so far as they were in force immediately before the 1st day of July 1976) shall, notwithstanding their revocation, continue to apply to animals introduced into New Zealand before the 1st day of July 1976.
- 3. Fees and charges—(1) Fees in respect of sustenance, care, and miscellaneous costs shall be payable as follows:

5. Other charges and expenses—Besides the charges specified in the foregoing provisions of these regulations for transport, sustenance, care, testing, and dipping, the costs and expenses of disinfecting animals, or the vessel by which they arrive, or the vehicle on which they are conveyed to the quarantine station, or the fittings used in connection with the animals, or the effects of their attendants, as well as all other charges and expenses of every description incurred in connection with the importation of animals shall be payable by the importer.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations prescribe new scales of fees for the transport, sustenance, care, testing, dipping, inspection, and other treatment of animals introduced into New Zealand on and after the 1st day of July 1976.
