## THE APPRENTICES REGULATIONS 1949, AMENDMENT NO. 1

# FREYBERG, Governor-General ORDER IN COUNCIL

At the Government House at Wellington, this 14th day of May 1952

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Apprentices Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

1. (1) These regulations may be cited as the Apprentices Regulations 1949, Amendment No. 1, and shall be read together with and deemed part of the Apprentices Regulations 1949\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the

date of their notification in the Gazette.

2. The principal regulations are hereby amended by revoking regulations 38 and 39 thereof, and substituting the following

regulations:—

"38. (1) Where the Commissioner is satisfied that any apprentice is obliged to live away from home in order to learn his trade he may authorize the payment to the apprentice of a lodging allowance at such rate as the Minister, with the concurrence of the Minister of Finance, from time to time approves in that behalf.

"(2) The lodging allowance, when so authorized, shall be payable through an officer of the Department of Labour and Employment to the apprentice on the certificate of the appropriate District

Commissioner.

"(3) Where an apprentice is required by an order of the Court or otherwise to live away from home in order to attend a course of instruction relating to his trade the Commissioner may authorize the payment to him of a lodging allowance in accordance with this regulation.

"(4) Application for a lodging allowance shall be made in form

"(5) Every lodging allowance shall be apportionable and shall be paid to the apprentice as the Commissioner, in his discretion, from

time to time directs.

"(6) A lodging allowance shall not be payable to an apprentice under suspension, and payment may be witheld by direction of the Commissioner if he has reason to doubt whether it continues to be properly payable.

\*"(7) If the Commissioner is satisfied that by reason of any change of circumstances an apprentice is no longer entitled to receive a lodging allowance, he may direct that the lodging allowance be no longer

payable."

"39. Where in the opinion of the Commissioner an apprentice might reasonably receive a lodging allowance under regulation 38 hereof but it is practicable and desirable for him to live at home, the Commissioner may in his discretion, having regard to the availability of moneys appropriated by Parliament for the purpose, authorize payment of a lodging allowance at a rate not exceeding the appropriate rate for the time being approved for lodging allowances under regulation 38 hereof and the provisions of that regulation shall, as far as they are applicable, and with the necessary modifications apply to any lodging allowance under this regulation."

#### EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations replace the existing provisions relating to the payment of lodging allowances to apprentices. The only material change is that the scale of allowances, instead of being set out in the regulations, will be fixed from time to time by the Minister. This will avoid the necessity of amending the regulations on each occasion a change of rates occurs.
