**THE APIARIES REGULATIONS 1952, AMENDMENT NO. 1**

**ORDER IN COUNCIL**

At the Government House at Wellington this 30th day of October 1957

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Apiaries Act 1927, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

1. These regulations may be cited as the Apiaries Regulations 1952, Amendment No. 1, and shall be read together with and deemed part of the Apiaries Regulations 1952\* (hereinafter referred to as the principal regulations).

2. Regulation 2 of the principal regulations is hereby amended by revoking the definition of the term "prohibited area", and substituting the following definition:

"'Prohibited area' means the area described in the Schedule hereto as set out in the Schedule to the Apiaries Regulations 1952, Amendment No. 1."

3. Regulation 6 of the principal regulations is hereby amended by omitting the words "any prohibited area", and substituting the words "the prohibited area".

4. Regulation 8 of the principal regulations is hereby amended by omitting the words "a prohibited area", and substituting the words "the prohibited area".

5. The principal regulations are hereby amended by revoking the Schedule, and substituting the Schedule set out in the Schedule to these regulations.

## SCHEDULE

## NEW SCHEDULE TO PRINCIPAL REGULATIONS

## SCHEDULE

## PROHIBITED AREA

ALL that area in the Tauranga, Rotorua, Whakatane, and Opotiki counties, and the boroughs of Whakatane and Kawerau, in the South Auckland and Gisborne Land Districts, bounded by a line commencing at a point in Block IV, Waihi South Survey District, being the intersection of the eastern boundary of Waewae-hikitea No. 1 Block with the shores of the Bay of Plenty, and running south-easterly along those shores to and southerly along the eastern boundary of Block VII and the eastern and southern boundaries of Block XI, Whakatane Survey District, to and along the eastern boundary of the Whakatane County as described in *Gazette* No. 37 of the 9th day of May 1957, page 808, to and along the northern and western boundaries of Block IV, and the western boundary of Block VIII, Waimana Survey District, and along the eastern boundary of the aforementioned Whakatane County to a point in line with the southern boundary of Block XVI, Waimana Survey District aforesaid; thence along a right line running due west to and along the northern boundaries of Blocks II and I, Urewera Survey District, and Blocks IV, III, and II, Galatea Survey District, to and northerly along the eastern boundaries of Blocks XIII, IX, and V, and the eastern and northern boundaries of Block I, Rangitai Lower Survey District, and continuing westerly along the northern boundaries of Blocks IV, III, II, and I, Ruawahia Survey District, and Block IV, Tarawera Survey District, to the north-western corner of that Block IV; thence again northerly along the eastern boundaries of Blocks XV and XI, the eastern and northern boundaries of Block VII, and the eastern boundary of Block II, the aforesaid blocks being of Rotoiti Survey District, and along the eastern boundaries of Blocks XIV and X, to and easterly generally along the generally southern boundaries of Blocks VII and VIII, the aforesaid blocks being of Maketu Survey District, to and along the southern boundary of Block II and the western boundary of Block VI, Waihi South Survey District, to and along the north-western and north-eastern boundaries of Section 1s, Hereford Park Settlement, the north-eastern boundary of Section 12, the north-eastern and eastern boundaries of Section 13, crossing an intervening public road and along the eastern boundaries of Sections 14, 15, and 22, the aforesaid sections being of Block VI, Waihi South Survey District, to and along the southern boundary of Lot 3, D.P.S. 2781, being part Section 4, Block VI aforesaid, along a right line across a public road and the Waitahanui River to and along the southern boundary of Lot 9, D.P. 8636, being part Tahunaroa No. 2 Block, the southern boundary of Section 7, Block VI aforesaid, the southern and eastern boundaries of part Lot 10 and the eastern boundaries of Lots 11, parts 13, 14, and 15, D.P. 8636 aforesaid, and Lots 6, 4, and 2, D.P. 35929, along a right line across the Paeroa-Whakatane State Highway to and along the eastern boundary of Part Lot 1, D.P. 8636 aforesaid, the aforesaid lots being parts Tahunaroa No. 2 Block, and along another right line across a public road to and along the eastern boundaries of Waewae-hikitea Nos. 3, 2A, and 2B Blocks, and the eastern

boundary of an Urupa, and along another right line across the East Coast Main Trunk Railway to and along the eastern boundary of Waewahikitea No. 1 Block aforementioned, to the point of commencement.

EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations extend the prohibited area within which bees may not be kept without a prior permit in writing from the Minister. The control is imposed because of the likelihood that honey produced in the area may contain poison.
