**ORDER IN COUNCIL**

At the Government House at Wellington this 26th day of May 1975

Present:

**HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL**

PURSUANT to the Auctioneers Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

**1. Title and commencement**—(1) These regulations may be cited as the Auctioneers Regulations 1958, Amendment No. 2, and shall be read together with and deemed part of the Auctioneers Regulations 1958\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 2nd day of June 1975.

**2. New scale of fees substituted**—(1) The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 2 of the Auctioneers Regulations 1958, Amendment No. 1 and amended by section 7 of the Decimal Currency Act 1964), and substituting the following Schedule:

"SECOND SCHEDULE

"SCALE OF FEES

1. For every licence issued to a company (except as provided in clause 3):	\$
(a) In respect of the first person specified in the licence as the person authorised to conduct auction sales under the licence .....	100.00
(b) Additional fee in respect of each other person specified in the licence as a person so authorised .....	50.00
(c) Where the company has more than one place of business, additional fee in respect of each place of business specified in the licence (other than the first) from which it carries on the business of an auctioneer .....	100.00
2. For every other licence (except as provided in clause 3)	100.00

Provided that, where applications are made for the issue of licences authorising two or more persons to conduct auction sales from the same place of business (being members or employees of the applicant's firm, or the applicant and his employee or the employees of the applicant), the fee for each such licence after the first shall be .....

3. For a licence available only in a special district under section 28 of the Act .....	20.00

4. Application by company to add name of person authorised to conduct auction sales under a licence .....	50.00

5. Notice by company of each additional place of business	100.00

For the purposes of this Schedule, only a branch office or place in charge of a resident officer of a company from which auctioneering activities are arranged and at which the books and ledgers relating to those activities are kept for the area controlled by the branch shall be deemed to be a place of business from which the company carries on business as an auctioneer."

(2) The Auctioneers Regulations 1958, Amendment No. 1 are hereby consequentially revoked.

EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

Regulation 2 substitutes a new and increased scale of fees payable in respect of licences issued and other applications made under the Auctioneers Act 1928.

Issued under the authority of the Regulations Act 1936.
