ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 74 of the Arms Act 1983, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Arms Regulations 1984, Amendment No. 1, and shall be read together with and deemed part of the Arms Regulations 1984* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 11th day of April 1988.
- **2. New scale of fees substituted**—The principal regulations are hereby amended by revoking the First Schedule, and substituting the First Schedule set out in the Schedule to these regulations.
- **3. Goods and services tax included**—The fees prescribed by the principal regulations (as amended by these regulations) are inclusive of goods and services tax under the Goods and Services Tax Act 1985.
