

# THE ACCIDENT REHABILITATION AND COMPENSATION INSURANCE (COMPLEX PERSONAL INJURY) INTERIM REGULATIONS 1994, AMENDMENT NO. 1

## ORDER IN COUNCIL

PURSUANT to section 167 of the Accident Rehabilitation and Compensation Insurance Act 1992, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Accident Rehabilitation and Compensation Insurance (Complex Personal Injury) Interim Regulations 1994, Amendment No. 1, and shall be read together with and deemed part of the Accident Rehabilitation and Compensation Insurance (Complex Personal Injury) Interim Regulations 1994\* (in these regulations referred to as the principal regulations).
- (2) These regulations shall come into force on the 28th day after the date of their notification in the Gazette.
- 2. Interpretation—Regulation 2 of the principal regulations is hereby amended by omitting from the definition of the term "social

rehabilitation" the words "but is not limited to", and substituting the words "without limitation".

- **8.** Interim character of regulations—Regulation 4 of the principal regulations is hereby amended by omitting the expression "1996", and substituting the expression "1998".
- 4. Limits on content of social rehabilitation programme—Regulation 16 of the principal regulations is hereby amended by omitting the expression "26 (5)", and substituting the expression "26A (4)".
- **5. Obligations of exempt employers**—The principal regulations are hereby amended by revoking regulation 23.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

The Accident Rehabilitation and Compensation Insurance (Complex Personal Injury) Interim Regulations 1994 prescribe the method by which the Corporation may provide for the social rehabilitation of a claimant who has suffered a complex personal injury. These regulations have 2 effects on those regulations. First, they extend the life of those regulations from 31 December 1996 to 31 December 1998. Second, they make minor changes consequential on the passage of the Accident Rehabilitation and Compensation Insurance Amendment Act (No. 2) 1996.
