THE APIARIES REGISTRATION REGULATIONS 1953, AMENDMENT NO. 1

COBHAM, Governor-General ORDER IN COUNCIL

At the Government House at Wellington this 30th day of July 1958

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Apiaries Act 1927, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Apiaries Registration Regulations 1953, Amendment No. 1, and shall be read together with and deemed part of the Apiaries Registration Regulations 1953* (hereinafter referred to as the principal regulations).
- **2.** Subclause (1) of regulation 3 of the principal regulations is hereby amended by adding the words "and may allot to each registration district a code letter:
- "Provided that each registration district specified in the Schedule to the Apiaries Registration Regulations 1958, Amendment No. 1, shall have the code letter appearing opposite its name in that Schedule, until a different code letter is allotted to it as aforesaid."
 - 3. The principal regulations are hereby amended by inserting, after

regulation 6, the following regulation:

- "6A. (1) In every registration district the Registrar shall allocate a code number to every apiary which is registered within that district and which is situated more than 10 chains from the usual place of residence of the person in whose name the apiary is registered, and shall notify that person of the code number allocated to that apiary.
- "(2) Where any code number is allocated to any apiary pursuant to subclause (1) of this regulation, the person in whose name the apiary is registered shall, within one month after the date on which he is officially informed that the code number has been allocated to that apiary, mark the code number clearly and conspicuously on the outside

of the brood chamber of at least one hive within the apiary, or on a marker post placed in a conspicuous position within the apiary, together with the code letter of the district within which the apiary is registered.

"(3) Every code letter and number marked on any hive or on any marker post pursuant to this regulation shall be black in colour and shall together be not less than $1\frac{1}{2}$ in. in width and not less than $1\frac{1}{2}$ in. in

height.

'(4) Every marker post placed in any apiary pursuant to this regulation shall be 2 in. × 2 in. in dimension and shall be painted white, and shall be fixed securely in the ground in a vertical position so that the marker post extends above the ground in which it is placed for a distance of not less than 2 ft."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations require all beekeepers to identify with a code letter, and with a code number to be supplied by the Department of Agriculture, all apiaries situated more than 10 chains from the usual place of residence of the person in whose name the apiary is registered.
