# THE ANIMAL REMEDIES REGULATIONS 1980, AMENDMENT NO. 1

#### ORDER IN COUNCIL

At the Government House at Wellington this 2nd day of June 1981

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 65 of the Animal Remedies Act 1967, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Animal Remedies Regulations 1980, Amendment No. 1, and shall be read together with and deemed part of the Animal Remedies Regulations 1980\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 14th day after the date of their notification in the *Gazette*.

2. Second Schedule to principal regulations amended—The Second Schedule to the principal regulations is hereby amended by omitting the items relating to Tiamulin hydrogen fumarate and Virginiamycin, and substituting the items set out in the Schedule to these regulations.

## SUBSTITUTED ITEMS IN SECOND SCHEDULE TO PRINCIPAL REGULATIONS

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations are made pursuant to the Animal Remedies Act 1967, and amend the Animal Remedies Regulations 1980.

Regulation 1 relates to the Title and commencement.

Regulation 2 amends the Second Schedule to the principal regulations. Regulation 36 (1) (b) of those regulations provides that no prescription poison or biochemical substance specified in that Schedule may be supplied or used otherwise than on the type of animal, within the maximum dosage, during the period, for the purpose, and subject to the limitations specified in that Schedule.

This regulation alters some of those matters in relation to the supply or use of Tiamulin hydrogen fumarate and Virginiamycin.
