THE ALEXANDER TURNBULL LIBRARY REGULATIONS 1966

ORDER IN COUNCIL

At the Government House at Wellington this 14th day of December 1966

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the National Library Act 1965, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Alexander Turnbull Library Regulations 1966.

(2) These regulations shall come into force on the day after the date of their notification in the Gazette.

2. In these regulations, unless the context otherwise requires,—

- "Library" means the Alexander Turnbull Library which forms part of the National Library of New Zealand established by the National Library Act 1965:
- "Library material" includes books, periodicals, newspapers, manuscripts, microfilms, films, sound recordings, musical scores, maps, plans, paintings, drawings, etchings, pictures, prints, and photographs, and such other related materials as the Minister, on the advice of the Trustees, by writing under his hand approves as library material for the purposes of the National Library Act 1965:

"Minister" means the Minister of Education:

"The Trustees" means the Trustees of the National Library established by the National Library Act 1965:

"Trustees' Special Committee" means the Trustees' Special Committee for the Alexander Turnbull Library established pursuant to paragraph (b) of subsection (1) of section 14 of the National Library Act 1965.

3. The Chief Librarian of the Alexander Turnbull Library, acting under the authority of the National Librarian in terms of the powers which may be delegated to him under section 7 of the National Library Act 1965,—

- (a) Shall cause the Library to be open for use at such times and under such conditions as the Minister, on the advice of the Trustees, may determine:
- (b) May make available for public exhibition in New Zealand or elsewhere, with the approval of the Trustees' Special Committee, any library material in the Library:

Provided that, in approving the terms and conditions under which such material shall be so made available, the Trustees' Special Committee shall have regard to the interests of readers visiting the Library, and to the physical condition of the material, its degree of rarity, and any risks to which it is likely to be exposed while in transit or in the custody of any other authority:

(c) May exchange for other material, give away, or sell any material a duplicate of which is already in the collections of the Library, or any material which is not appropriate to those collections: Provided that no library material forming part of the bequest of Alexander Horsburgh Turnbull shall be exchanged

for other library material or given away or sold: Provided also that no library material forming part of

Provided also that no library material forming part of a donation or a bequest to the Library shall be exchanged for other library material or given away or sold if such an act is inconsistent with the conditions imposed by or implicit in connection with the donation or bequest:

(d) May, with proper regard for the interests of readers visiting the Library, the physical condition and the degree of scarcity of the library material, and to any risks to which it is likely to be exposed, lend library material to the librarian of another library in New Zealand for use within that library:

Provided that library material shall not be so lent if-

- (i) It is a rare book, a manuscript piece, a map, a painting, or a unique item; or
- (ii) It forms part of the bequest of Alexander Horsburgh Turnbull; or
- (iii) It forms part of a donation or a bequest, a loan from which would be inconsistent with the conditions imposed or implied by the donor or person making the bequest:
- (e) May allow to be copied outside the Library by photo copying or other suitable method photographic negatives and other library material.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations prescribe the conditions governing the use of library material in the Alexander Turnbull Library.
