ORDER IN COUNCIL

At the Government House at Wellington, this 25th day of October, 1950

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Agricultural Workers Act, 1936, and after submission by the Minister of Labour to the organization of the workers of the class affected and to the organization of their employers of the proposal to vary the Agricultural Workers (Farms and Stations) Extension Order 1949 as hereinafter appears, and after approval in all material particulars by the said organizations of the provisions herein contained except those which are contained in clauses 2, 3, and 4 which were in dispute between them and were accordingly referred to the Court of Arbitration for a recommendation, all the said provisions herein contained being however in accordance with the proposals of the said Minister and the recommendation of the Court of Arbitration, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby order as follows:—

- 1. (1) This Order may be cited as the Agricultural Workers (Farms and Stations) Extension Order 1949, Amendment No. 1, and shall be read together with and deemed part of the Agricultural Workers (Farms and Stations) Extension Order 1949* (hereinafter referred to as the principal Order).
- (2) This Order shall be deemed to have come into force on the 8th day of May, 1950.
- 2. Clause 1 of the Schedule to the principal Order is hereby revoked and the following clause substituted:—
- "1. Except as hereinafter provided, every worker shall be entitled to receive from his employer payment for his work at such rate as is agreed upon, being not less than the appropriate rate as prescribed hereunder:—

- 3. Clause 3 of the Schedule to the principal Order is hereby amended as follows:—
 - (a) By omitting from subclause (1) the expression "£1 5s.", and substituting the expression "£1 6s. 9d.":
 - (b) By omitting from subclause (2) the expression "£1", and substituting the expression "£1 1s. 3d."
- 4. Clause 6 of the Schedule to the principal Order is hereby revoked and the following clause substituted:—
 - "6. The rates payable to casual workers shall be not less than the following:—

EXPLANATORY NOTE

[This note is not part of the Order, but is intended to indicate its general effect.]

This Order embodies in the Agricultural Workers (Farms and Stations) Extension Order 1949 the effect of the interim general wage order made by the Court of Arbitration on the 10th June, 1950. On the recommendation of the Court the increase has been incorporated in the actual wage rates.

Issued under the authority of the Regulations Act, 1936. Date of notification in *Gazette*: 26th day of October, 1950.
