

THE AGRICULTURAL WORKERS (TOBACCO GROWERS) EXTENSION ORDER 1954, AMENDMENT NO. 3

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Agricultural Workers Act 1936, and after submission by the Minister of Labour to the organisation of the workers of the class affected and to the organisation of their employers of the proposal to vary the Agricultural Workers (Tobacco Growers) Extension Order 1954* as hereinafter appears, and after approval in all material particulars by the said organisations of the provisions herein contained, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. (1) This order may be cited as the Agricultural Workers (Tobacco Growers) Extension Order 1954, Amendment No. 3, and shall be read together with and deemed part of the Agricultural Workers (Tobacco Growers) Extension Order 1954* (hereinafter referred to as the principal order).
- (2) This order shall be deemed to have come into force on the 1st day of May 1958.
- 2. Clause 18 of the Schedule to the principal order is hereby amended by omitting from subclause (2) the expression "3s. 2d.", and substituting the expression "3s. 6d.".
- 3. (1) Clause 19 of the Schedule to the principal order is hereby amended by revoking subclause (1) (as substituted by clause 3 of the Agricultural Workers (Tobacco Growers) Extension Order 1954, Amendment No. 1),* and substituting the following subclause:

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order is in accordance with an agreement between the organisations of employers and workers in the tobacco industry in the Nelson District. It gives effect, as from 1 May 1958, to an increase in the wages, shift allowance, and meal money of agricultural workers employed in the shed section of the industry.
