ORDER IN COUNCIL

At the Government House at Wellington this 16th day of December 1968.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to Part III of the Agricultural Workers Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Agricultural Workers (Orchardists) Order 1965, Amendment No. 2, and shall be read together with and deemed part of the Agricultural Workers (Orchardists) Order 1965* (hereinafter referred to as the principal order).
- (2) Except as provided in subclause (3) of this clause, this order shall come into force on the day after the date of its notification in the *Gazette*, and shall continue in force until the 30th day of November 1970, and thereafter until a further order is made in substitution therefor.
- (3) The provisions of this order relating to wages shall be deemed to have come into force on the 1st day of December 1968.
- 2. Wages of permanent workers—The Schedule to the principal order is hereby amended by revoking clause 3 (as substituted by clause 2 of the Agricultural Workers (Orchardists) Order 1965, Amendment No. 1), and substituting the following clause:

3. Wages of casual workers—The Schedule to the principal order is hereby further amended by revoking clause 4 (as substituted by clause 3 of the Agricultural Workers (Orchardists) Order 1965, Amendment No. 1), and substituting the following clause:

"4. The minimum rates of wages for casual workers shall be as

4. Special payments—Clause 6 of the Schedule to the principal order (as amended by clause 4 of the Agricultural Workers (Orchardists) Order 1965, Amendment No. 1) is hereby amended by omitting from subclause (1) the words "5d. (4.166 cents) per hour" in both places where they occur, and substituting in each case the words "5c per hour".

5. Notification—The Schedule to the principal order is hereby further

amended by adding, after clause 18, the following clause:

"19. Every employer shall, after being requested to do so by an officer or authorised representative of the New Zealand Workers' Industrial Union of Workers, supply the names and addresses of the workers who are employed by him and to whom this order applies."

6. Revocations—The Agricultural Workers (Orchardists) Order 1965, Amendment No. 1, is hereby consequentially amended by revoking subclause (3) of clause 1 and clauses 2 to 4.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect. This order amends the Agricultural Workers (Orchardists) Order 1965. It increases, as from 1 December 1968, rates of wages payable to agricultural workers employed in orchards. It also increases the rate payable under the special payments clause. A new clause has been inserted which enables the union to obtain from an employer the names and addresses of workers.
