Pursuant to section 14 of the Agricultural Workers Act 1936, and having regard to the prices for the time being fixed under sections 16 and 36 of the Dairy Products Marketing Commission Act 1947, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

### ORDER

- 1. (1) This order may be cited as the Agricultural Workers Wages Order 1952.
- (2) This order shall be deemed to have come into force on the 1st day of August 1952, and shall continue in force until the 31st day of July 1953, and thereafter until a further order is made in substitution therefor.
- 2. (1) Subject to the provisions of this clause, the following shall be the minimum rates of wages payable under the said section 14 to agricultural workers employed on dairy farms:—

(2) The above rates shall be deemed to include allowance for work done at week-ends and on holidays as part of the normal week's work.

(3) In the case of those workers who are not provided with board and lodging by their employers the aforesaid rates shall be increased by £1 10s. a week.

3. The following shall be the minimum rates of wages payable under the said section 14 to casual workers employed on dairy farms:—

#### EXPLANATORY NOTE

[This note is not part of the order, but is intended to indicate its general effect.]

This order increases as from 1 August 1952 the wage rates in paragraphs (a) to (f) of clause 2 (1) by 8s. 6d., 10s., 12s., 13s. 6d., 15s. 3d., and 17s. respectively, including allowances for work done at week-ends and on holidays as part of the normal week's work. It also increases from £1 8s. 9d. to £1 10s. the additional amount payable by the employer in cases where the worker is not provided with board and lodging.

The minimum wage rates prescribed in clause 3 for casual workers have also been increased having regard to the rates specified in the standard wage pronouncement

made by the Court of Arbitration on 12 July 1952.
