REGULATIONS 1977**

ORDER IN COUNCIL

At the Government House at Wellington this 4th day of July 1977

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Births and Deaths Registration Act 1951, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Births and Deaths Registration Fees Regulations 1977.

(2) These regulations shall come into force on the 15th day of July 1977.

2. Fees—There shall be paid to the Registrar-General and to every Registrar for the various matters set out in the Schedule to these regulations the respective fees specified in that Schedule.

3. Revocation—The Births and Deaths Registration Fees Regulations 1975* are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 prescribes a new and increased scale of fees payable under the Births and Deaths Registration Act 1951 to the Registrar-General and to Registrars. The new scale comes into force on 15 July 1977.
