ORDER IN COUNCIL

At Wellington this 30th day of October 1989

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to sections 45 and 50 of the Births and Deaths Registration Act 1951, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Births and Deaths Registration (Fees) Regulations 1989.
- (2) These regulations shall come into force on the 1st day of December 1989.
- 2. Fees—There shall be paid to the Registrar-General or, as the case requires, to a Registrar, for each of the matters specified in the Schedule to these regulations, the fee specified for it in that Schedule.
- **3.** Amount of goods and services tax included—The fees prescribed in these regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985.

4. Revocation—The Births and Deaths Registration (Fees) Regulations 1988* are hereby consequentially revoked.

Births and Deaths Registration (Fees) Regulations 1989

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 December 1989, increase the fees payable under the Births and Deaths Registration Act 1951 to the Registrar-General and to Registrars.
