THE BOBBY CALF MARKETING REGULATIONS 1938.

GALWAY, Governor-General.

ORDER IN COUNCIL.

At the Government House at Wellington, this 22nd day of June, 1938.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

Pursuant to the Primary Products Marketing Act, 1936, and the Agriculture (Emergency Powers) Act, 1934, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council doth hereby make the following regulations.

REGULATIONS.

- 1. These regulations may be cited as the Bobby Calf Marketing Regulations 1938.
- 2. These regulations shall come into force on the day following notification in the *Gazette* of the making thereof.*
 - 3. In these regulations, unless inconsistent with the context,—
 - "Bobby calf" means a calf which is intended for slaughter for human consumption as boneless veal:
 - "Committee" means a Bobby Calf Pool Committee established under these regulations:
 - "Minister" means the Minister of Marketing:
 - "Pool area" means a Bobby Calf Marketing Pool Area defined pursuant to these regulations:
 - "Producer" means a person engaged in the business of raising or producing bobby calves intended for sale:
 - "Sale" includes a contract for sale, agreement to sell, and offer for sale; "purchase" includes a contract for purchase, agreement to purchase, and offer to purchase; "sale" and "purchase" include barter and exchange; and "to sell" and "to purchase" have corresponding meanings.
- **4.** Upon being satisfied on such documentary evidence as he shall deem sufficient that a sufficient majority of the producers in any area of land are desirous that such area should be declared to be a pool area for the marketing of bobby calves, the Minister may, by notice under his hand published in the *Gazette*, declare the area of land defined in such notice to be a Bobby Calf Marketing Pool Area under a name to be set out in such notice.

- 5. Upon being satisfied as aforesaid, the Minister may by like notice declare any additional area of land (whether or not already comprised in a pool area) to be part of any pool area, or may declare any land theretofore included in a pool area to be no longer part thereof, or may declare that any area of land shall no longer be a pool
- 6. Every notice given under the two last preceding clauses hereof shall take effect on a date to be named therein, being not less than seven days after the publication thereof.

7. For every pool area there shall be a Committee, to be known as "The [Name of Pool Area] Bobby Calf Pool Committee."

8. Every Committee shall consist of such persons as the Minister may from time to time appoint thereto after such consultation as he thinks expedient with representatives of the producers in the pool area for which the Committee is established.

- 9. Every appointment of a member of a Committee shall be made by notification under the hand of the Minister published in the Gazette, and shall take effect on the date of notification or such later date as may be stated therein.
- 10. Every member of a Committee shall hold office for a term of one year from the time when his appointment takes effect, and thereafter until a substituted appointment is made and takes effect, subject, however, to removal as hereinafter provided.
- 11. Any member of a Committee may, by notification under the hand of the Minister published in the Gazette, be removed from office if he requests the Minister to be allowed to resign, or be removed, or upon any ground on which if he were a Councillor of a County Council he would be incapable of being or remaining a Councillor by virtue of paragraphs (c) to (f) of subsection (1) of section 62 of the Counties Act, 1920, or upon the ground of continued absence without leave from meetings of the Committee.
- 12. Notification of appointment of any person in substitution for a member shall take effect as a removal from office of the lastmentioned member as at the date at which such appointment takes effect.
- 13. The powers of a Committee shall not be affected by any vacancy in the membership thereof, nor shall the proceedings of a Committee be invalidated by reason only of the subsequent discovery that some defect existed in the appointment of any member or that any person acting as a member was not validly a member thereof.
- 14. The Minister may, by notification as aforesaid, fix the time and place for the first meeting or any special meeting of a Committee.
- 15. Subject to the foregoing provisions, every Committee may make such arrangements as it thinks fit for the holding of meetings, the procedure thereat, and generally for the conduct of its business and exercise of its functions.
- 16. In particular a Committee may from time to time appoint and discharge sub-committees consisting of two or more persons, whether members of the Committee or not, and may delegate to a sub-committee any of the powers and functions of the Committee.
- 17. The functions of a Committee shall be to regulate and control in such manner as it thinks fit the marketing of all bobby calves raised or produced within the pool area for which the Committee is established.

- 18. Every Committee shall in the exercise of its powers and functions be deemed to be the agent of every producer for the marketing of bobby calves raised or produced within the pool area, and the mutual rights, obligations, and liabilities of the Committee and the several producers shall accordingly be determined in accordance with the law governing the relations between principal and agent.
- 19. No producer carrying on business within any area of land declared to be a pool area for the purposes of these regulations shall sell, and no person shall purchase, any bobby calf raised or produced in that area except through the agency of the Committee established for that area.
- 20. Every person who sells or purchases any bobby calf in breach of the provisions of these regulations is guilty of an offence against these regulations.
