THE BOBBY CALF MARKETING REGULATIONS 1947, **AMENDMENT NO. 4**

ORDER IN COUNCIL

At the Government Buildings at Wellington, this 3rd day of June 1952

PURSUANT to the Marketing Act 1936 and the Agriculture (Emergency Powers) Act 1934. His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Bobby Calf Marketing Regulations 1947. Amendment No. 4, and shall be read together with and deemed part of the Bobby Calf Marketing Regulations 1947* (hereinafter referred to as the principal regulations).

2. Regulation 31 of the principal regulations is hereby amended by revoking subclause (2) (as set out in regulation 2 of the Bobby Calf Marketing Regulations 1947, Amendment No. 1), and substituting the following subclause:-

"(2) For all vells purchased by it under these regulations the Board shall pay to the controlling authority or to the licensee, as the case may be, the following prices:

"(a) 2s. per vell for all first-grade vells:

"(b) 1s. per vell for all other vells."

3. Subclause (2) of regulation 32 of the principal regulations is hereby amended as follows:-

- (a) By omitting the words "the 1st day of May", and substituting the words " the 1st day of June ":
- (b) By omitting the words "the 30th day of April", and substituting the words "the 31st day of May".

4. Regulation 33 of the principal regulations is hereby amended by revoking subclause (1) (as set out in regulation 2 of the Bobby Calf Marketing Regulations 1947, Amendment No. 2), and substituting the following subclause:—

"(1) On and after the 1st day of June 1952 the price to be charged by the Board and paid by the company under these regulations shall be—

" (a) 1s. 6d. per vell for the first 700,000 first-grade vells sold by the Board to the company:

"(b) 9d. per vell for all second-grade vells."

5. The Bobby Calf Marketing Regulations 1947, Amendment No. 1, and the Bobby Calf Marketing Regulations 1947, Amendment No. 2, are hereby revoked.

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

Regulations 2 and 4 increase the price payable by the New Zealand Dairy Board for vells and authorize a corresponding increase for vells sold by the Board.

Regulation 3 alters the period in respect of which the New Zealand Cooperative Rennet Co. is required to furnish to the Board an estimate of the vells that the company will require.
