THE BOBBY CALF MARKETING REGULATIONS 1947, AMENDMENT NO. 5

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Marketing Act 1936 and the Agriculture (Emergency Powers) Act 1934, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. (1) These regulations may be cited as the Bobby Calf Marketing Regulations 1947, Amendment No. 5, and shall be read together with and deemed part of the Bobby Calf Marketing Regulations 1947* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- **2.** Regulation 36 of the principal regulations is hereby amended by adding the following subclause:—
- "(3) All bobby calves shall be transported in accordance with regulation 8 (3) of the Goods Service Vehicle (Constructional) Regulations 1936†."
- **3.** The First Schedule to the principal regulations is hereby amended by revoking clause 5, and substituting the following clause:—
- "5. (1) Any producer may at any annual meeting give notice of motion that the number of members of the Committee to be elected at the next succeeding annual meeting shall be the number specified in the notice, and the said succeeding annual meeting may, by ordinary resolution, determine that the number of members so specified shall be the number for the next ensuing year.

"(2) Whether or not any such notice of motion has been given an annual meeting may, by unanimous resolution, determine the number of members of the Committee to be elected at that meeting.

"(3) If no such notice of motion has been given or if the motion is not carried the number of members of the Committee (in the absence

of a unanimous resolution as aforesaid) shall remain unchanged.

"(4) At the first annual meeting of producers the number of members of the Committee for the ensuing year shall be determined by ordinary resolution."

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

Regulation 2 ensures that the provisions of regulation 8 (3) of the Goods Service (Constructional) Regulations 1936 (which provides for the comfortable transport of stock) apply to the transport of bobby calves.

Regulation 3 provides that the number of members of Bobby Calf Committees shall be determined either in accordance with a notice of motion given at the preceding annual meeting or with a unanimous resolution at the meeting at which

the election is held.
