**THE BEER DUTY DISTRICTS ORDER 1951**

PURSUANT to Part III of the Finance Act 1915, the Minister of Customs hereby makes the following order.

ORDER

1. (1) This order may be cited as the Beer Duty Districts Order 1951.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. (1) The districts specified in the Schedule hereto are hereby appointed as districts for the purpose of levying and collecting beer duty.

(2) Each of those districts shall comprise the counties specified in that behalf in the Schedule hereto and (except as otherwise indicated) all boroughs and town districts which are within the outer boundaries of those counties or are bounded by those counties or are between those counties or any part thereof and the sea.

3. The places for the payment of beer duty in each of those districts shall be the places specified in that behalf in the Schedule hereto.

4. The warrants dated the 1st day of July 1929,\* the 6th day of May 1932†, the 13th day of July 1933‡, and the 26th day of February 1943§, appointing districts and places for collecting beer duty, are hereby revoked.

## EXPLANATORY NOTE

[This note is not part of the order, but is intended to indicate its general effect].

This order replaces four notices in the *Gazette* appointing districts and places for collecting beer duty under Part III of the Finance Act 1915.

The only changes are those consequent upon the closing of Hokitika and Patea as Customs ports of entry as from 1 December 1950 and 1 July 1951 respectively. Patea and Hawera counties are now included in the Wanganui and New Plymouth districts respectively, and the county of Westland is included in the Greymouth district. Provision is made for payment of beer duty at the post office, Hokitika.
