THE BREADMAKING INDUSTRY CONTROL ORDER 1943

PURSUANT to the Supply Control Emergency Regulations 1939,* the Minister of Supply and Munitions doth hereby make the following order.

ORDER.

1. This Order may be cited as the Breadmaking Industry Control Order 1943.

2. This Order shall come into force on the 1st day of April, 1943.

3. In this Order, unless the context otherwise requires,-

"The said specification" means the New Zealand Emergency Standard Specification entitled "New Zealand Emergency Standard Specification for Bread ", issued by the New Zealand Standards Institute under the authority of the Minister of Industries and Commerce, bearing date February, 1943, and numbered N.Z.S.S. E.82[†], and includes any amendment thereof that may hereafter be issued or any specification that may hereafter be issued in substitution therefor.

4. No person whose business or part of whose business is baking bread for sale or selling bread shall bake, sell, or keep for sale any bread which when baked weighs 6 oz. or more unless the bread is of one of the classes described in the said specification and conforms to the provisions of the said specification or the terms of any approval thereunder:

Provided that a loaf of bread baked in the form of a split loaf as described in the said specification may be split into two approximately equal parts if that is necessary to provide an intending purchaser with half a split loaf.

5. Every person whose business or part of whose business is baking bread for sale or selling bread shall sell a loaf of not less than 2 lb. weight to any person desiring to purchase such a loaf:

Provided that if at any time a loaf of 2 lb. weight is not available for sale a loaf of that weight shall be supplied on the day after an order therefor is placed.

6. Every person whose business or part of whose business is baking bread for sale or selling bread shall supply white bread or wholemeal bread as described in the said specification to any person desiring to purchase white bread or wholemeal bread, as the case may be:

Provided that if at any time bread of the class required is not available for sale bread of that class shall be supplied within two days after an order therefor is placed.

7. Every person whose business or part of whose business is selling bread shall display in full view of the public in any premises wherein bread is kept for sale a notice not less than 17 in. by $11\frac{1}{2}$ in. on which shall be clearly and legibly printed in bold type of not less than 30 points face measurement the classes, shapes, and weights of the loaves offered for sale, designated in accordance with the corresponding terms used in the said specification.
