THE BOILERS, LIFTS, AND CRANES EXEMPTION NOTICE 1983

PURSUANT to sections 10 and 19 of the Boilers, Lifts and Cranes Act 1950, the Minister of Transport hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Boilers, Lifts, and Cranes Exemption Notice 1983.

(2) This notice shall come into force on the 14th day after the date of its notification in the *Gazette*.

2. Exemptions from section 10 of Boilers, Lifts, and Cranes Act 1950—Acting on the recommendation of the Chief Surveyor, the Minister of Transport hereby exempts the boilers and machinery referred to in the Schedule to this notice from the provisions of section 10 of the Boilers, Lifts, and Cranes Act 1950.

3. Exemptions from section 19 of Boilers, Lifts, and Cranes Act 1950—The Minister of Transport hereby exempts the boilers and machinery referred to in the Schedule to this notice from the provisions of section 19 of the Boilers, Lifts, and Cranes Act 1950.

4. Revocations—The Boilers, Lifts, and Cranes Exemption Notice 1967* and the Boilers, Lifts, and Cranes Exemption Notice 1971† are hereby revoked.

SCHEDULE

Clauses 2, 3

BOILERS AND MACHINERY EXEMPTED FROM SECTIONS 10 AND 19 OF THE BOILERS, LIFTS, AND CRANES ACT 1950

1. Boilers that are-

(a) Cylinders exceeding 250 litres water capacity; and

(b) Used for the transport of permanent or liquid gases; and

(c) Filled only at filling stations that have been approved as such by the Chief Engineer Surveyor for the purposes of this exemption.

2. Boilers not exceeding 0.2 cubic metres water capacity that have a working pressure not exceeding 105 kPa and are used on a farm by a farmer or a person acting under his direction, exclusively for cooking food for dogs.

3. Boilers heated by electricity which-

(a) Do not exceed 0.06 cubic metres water capacity; and

(b) Have a working pressure not exceeding 75 kPa; and

(c) Are used to supply instant boiling water for heating food and cleaning, cooking, eating, and drinking utensils in coffee bars, hotel bars, restaurants, cafeterias, canteens, or other similar establishments.

4. Model boilers not exceeding 0.03 cubic metres water capacity which are used as toys or by members of Incorporated Model Clubs.

5. Boilers which-

(a) Do not exceed 0.06 cubic metres water capacity; and

(b) Have a working pressure not exceeding 105 kPa; and

(c) Are used for domestic purposes only.

6. Boilers which are provided with an adequate open vent and in which the working pressure does not exceed 15 kPa.

7. Boilers not exceeding 0.06 cubic metres water capacity which are used as receivers for gas.

8. Boilers not exceeding 0.15 cubic metres water capacity which are used as receivers for compressed air.

9. Boilers which are used as air-pressurised water tanks for supplying water to domestic and farm water systems.

10. Lifts which are used for domestic purposes only in private homes.

11. Lifts of the direct acting plunger type in which the underside of the car or platform is directly attached to a ram or plunger and which—

(a) Have a travel of not more than one floor with a maximum of 4.30 metres; and

(c) Are used for the conveyance of goods or materials only.

12. Lifts used to lift motor vehicles for repair, maintenance, or lubrication, the travel of which does not exceed 2.15 metres.

13. Cranes used solely for lifting and towing damaged or broken-down motor vehicles.

GEORGE F. GAIR, Minister of Transport. This note is not part of the notice, but is intended to indicate its general effect.

This notice exempts various categories of boilers and machinery from sections 10 and 19 of the Boilers, Lifts, and Cranes Act 1950 which relate to the inspection of boilers and machinery.

The only new exemption relates to cylinders with a capacity in excess of 250 litres and used for the transport of permanent or liquid gases.

The other exemptions were previously set out in the notices revoked by clause 4 of this notice, and have been carried forward with changes to express capacities, pressures, and distances in metric terms.
