

THE BOILERS, LIFTS, AND CRANES EXEMPTION NOTICE 1990

Pursuant to sections 10 and 19 of the Boilers, Lifts, and Cranes Act 1950, the Minister of Transport hereby gives the following notice.

NOTICE.

- 1. Title and commencement—(1) This notice may be cited as the Boilers, Lifts, and Cranes Exemption Notice 1990.
- (2) This notice shall come into force on the 28th day after the date of its notification in the Gazette.
- 2. Exemptions from section 10 of Boilers, Lifts, and Cranes Act 1950—Acting on the recommendation of the Chief Surveyor, the Minister of Transport hereby exempts the boilers and machinery referred to in the Schedule to this notice from the provisions of section 10 of the Boilers, Lifts, and Cranes Act 1950.
- **3. Exemptions from section 19 of Boilers, Lifts, and Cranes Act 1950**—The Minister of Transport hereby exempts the boilers and machinery referred to in the Schedule to this notice from the provisions of section 19 of the Boilers, Lifts, and Cranes Act 1950.

SCHEDULE

Clauses 2, 3

BOILERS AND MACHINERY EXEMPTED FROM SECTIONS 10 AND 19 OF THE BOILERS, LIFTS, AND CRANES ACT 1950

- 1. Boilers that generate steam by heat transfer in a continuous coil where—
 - (a) The total combined volumes of the steam separator, the steam drum, and the steam and water drum do not exceed 10 litres in water volume; and
 - (b) The effective heating surface of the boiler does not exceed 7.5 square metres in area.
 - 2. Electric sterilisers that—
 - (a) Are of the type that have a water reservoir that is manually replenished; and

SCHEDULE—continued

BOILERS AND MACHINERY EXEMPTED FROM SECTIONS 10 AND 19 OF THE BOILERS, LIFTS, AND CRANES ACT 1950—continued

(b) Have an internal volume not exceeding 10 litres.

- 3. Pressure cookers and pressure fryers having a safe working pressure not exceeding 200 kPa and an internal volume not exceeding 0.1 cubic metres.
- 4. Boilers that are used exclusively for providing water to make tea or coffee and have an internal volume not exceeding 10 litres.
 - 5. Steam turbines with a maximum rated output not exceeding 250 kW.

6. Clothes presses and tyre moulds.

- 7. Air receivers of welded or seamless shell construction that have an internal capacity not exceeding 0.5 cubic metres.
- 8. Pressure vessels containing pre-dried filtered air that are used exclusively to supply blast air to electrical circuit breakers.
- 9. Pressure vessels containing air or gas (whether or not they also contain water) that are used to pressurise water supply systems and do not exceed 2 cubic metres in internal volume.
- 10. Pressure vessels containing air or gas (whether or not they also contain fluid) that are used to pressurise hydraulic systems and do not exceed 1 cubic metre in internal volume.
- 11. Pressure vessels, containing gases with electrical insulating properties, that are used to isolate contained electrical equipment.

12. Domestic and commercial air conditioning or heat pump equipment using refrigerant gases that are both non toxic and non flammable.

13. Every crane with a maximum safe load not exceeding 5 tonnes that is attached to a vehicle and is used for the purpose of loading and unloading that vehicle.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice exempts various categories of boilers and machinery from sections 10 and 19 of the Boilers, Lifts, and Cranes Act 1950. Those provisions relate to the inspection of boilers and machinery.
