# THE BOILERS, LIFTS, AND CRANES (FEES) REGULATIONS 1951, AMENDMENT NO. 1

ORDER IN COUNCIL

At the Government House at Wellington, this 11th day of August 1954

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Boilers, Lifts, and Cranes Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

# REGULATIONS

1. (1) These regulations may be cited as the Boilers, Lifts, and Cranes (Fees) Regulations 1951, Amendment No. 1, and shall be read together with and deemed part of the Boilers, Lifts, and Cranes (Fees) Regulations 1951\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of October 1954.

2. The principal regulations are hereby amended by revoking regulation 4, and substituting the following regulation:

"4. The fees payable to the Secretary in respect of the second and every subsequent inspection of boilers or machinery under the Act shall be in accordance with the table of fees set out in the Schedule to these regulations, and in respect of the first inspection of any such boilers or machinery the fees payable to the Secretary shall be double the amount so payable in respect of a second inspection."

3. The principal regulations are hereby amended by revoking the Schedule thereto, and substituting the Schedule set out in the Schedule to these regulations.
