Pursuant to the Milk Act 1944, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. (1) This order may be cited as the Blenheim Milk District Order 1957.
- (2) This order shall come into force on the day after the date of its notification in the Gazette.
- 2. The Blenheim Milk District, as constituted by the Blenheim Milk District Constitution Order 1945,* shall hereafter consist of the Borough of Blenheim and part of the County of Marlborough; and the boundaries of the said district shall be those specified in the Schedule hereto.
- 3. The Blenheim Borough Council shall continue to be the Milk Authority of the said district.
- 4. The Marlborough County Council shall continue to be entitled to have two representatives on the Milk Committee of the Blenheim Borough Council and from time to time to nominate two persons for that purpose.
- 5. The Blenheim Borough Council shall from time to time appoint to the Milk Committee of the Borough Council the two persons nominated by the Marlborough County Council pursuant to clause 4 hereof.
- 6. This order is in substitution for the Blenheim Milk District Constitution Order 1945,* and that order is hereby revoked.

SCHEDULE

THE BLENHEIM MILK DISTRICT

All that area bounded by a line commencing at the junction of the northern side of Middle Renwick Road with the western boundary of Section 160, Omaka District, Block XIII, Cloudy Bay Survey District; thence proceeding northerly along the western boundary of the said Section 160, across a public road, to and along the western boundary of Section 36, Block I, Waihopai District, and its production to the southern boundary of Section 5, River Protection Reserve, Block IX, Cloudy Bay Survey District; thence easterly along the generally southern boundary of the said Section 5, across a public road, and along the southern boundary of Section 6, Gravel Reserve, Block IX aforesaid, to the western boundary of Lot 1, D.P. 1297; thence northerly along the western boundary of the said Lot 1 to the north-western corner of that lot; thence easterly and south-easterly generally along the northern boundary of the said Lot 1, and the north-eastern boundaries of Lot 2, D.P. 1297, and Section 43, Block I, Omaka District, to the north-eastern corner of the last-mentioned section; thence southerly along the eastern boundaries of the said Section 43 and Section 38, Block I, Waihopai District, and the production of the last-mentioned boundary to the southern side of Old Renwick Road; thence easterly along the southern side of that road and the southern side of Robinson Street and its production to the right bank of the Opawa River; thence down the right bank of that river to a point west of, and distant 8 chains from, the western side of the Blenheim-Picton State Highway; thence northerly generally along a line parallel to, and distant 8 chains west of, the western side of the said State Highway to the right bank of the Wairau River; thence down the right bank of that river to a point in line with the north-western boundary of Lot 18, D.P. 937, in Block XVII, Cloudy Bay Survey District; thence south-westerly to and along that boundary and the north-western boundaries of Lot 14, D.P. 938, Lot 1, D.P. 941, Lot 6, Deeds Plan 67, across Vickerman Street to and along the north-western boundaries of Lots 7, 4, 1, 5, and again Lot 1, all of D.P. 271, and the production of the last-mentioned boundary across the South Island Main Trunk Railway to the eastern side of the Blenheim-Picton State Highway; thence southerly along the eastern side of that highway to its intersection with the right bank of the Opawa River; thence down the right bank of that river to a point in line with the western boundary of Section 24, Wairau West District; thence southerly to and along that boundary and its production to the right bank of the Opawa River; thence down the right bank of that river to the eastern boundary of Section 33, Opawa District; thence southerly along that boundary and its production to the southern side of the Picton-Christchurch State Highway; thence westerly along the southern side of that highway to and along the road forming the northern boundaries of Sections 34, 36, 38, 40, and 42, Opawa District, to the western boundary of the last-mentioned section; thence southerly along that boundary to the south-western corner of the said Section 42; thence westerly along a right line to the south-eastern corner of Section 1 of 8, Wither Settlement, along the southern boundaries of the said Section 1 of 8 and Sections 30, 6, 5, 4, and 3, all of Wither Settlement, and the production of the last-mentioned boundary to the eastern side of St. Leonards Road; thence northerly along the eastern side of that

road to the northern side of Middle Renwick Road; thence westerly along the northern side of that road to the point of commencement: as the same is more particularly delineated on plan No. 181/2 deposited in the office of the Milk Authority of the Blenheim Milk District.
