# ORDER IN COUNCIL

# At the Government House at Wellington, this 16th day of February, 1949

## Present :

## HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the British Nationality and New Zealand Citizenship Act, 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

# REGULATIONS

1. These regulations may be cited as the British Nationality and New Zealand Citizenship Regulations 1949.

2. In these regulations, unless the context otherwise requires,—

"The Act" means the British Nationality and New Zealand Citizenship Act, 1948:

Expressions defined in the Act have the meanings so defined.

# REGISTRATION OF NEW ZEALAND CITIZENS

**3.** (1) An application by a person of full age for registration as a New Zealand citizen under section 8 or section 9 of the Act shall include the particulars in the form numbered 1 in the First Schedule hereto.

(2) An application for the registration of a minor as a New Zealand citizen under section 9 of the Act shall include the particulars in the form numbered 2 or 4 in the First Schedule hereto, whichever is applicable.

**4.** (1) For the purposes of the Act a register of persons becoming New Zealand citizens by registration shall be kept in the Department of Internal Affairs at Wellington.

(2) The Minister shall cause proper indexes to be made of the names of persons registered as aforesaid, and shall permit every person desirous of so doing to inspect the same and make copies thereof.

## CITIZENSHIP BY NATURALIZATION

5. (1) Notice of intention to apply for naturalization as a New Zealand citizen shall be lodged with the Minister and shall also be published for public information in such form as the Minister may direct.

(2) The notice of intention to be lodged with the Minister shall be in the form numbered 3 in the First Schedule hereto. 1949/7]

(3) The notice of intention for public information shall be published by and at the expense of the declarant in two newspapers circulating in the district where he resides and in such other newspapers as the Minister may direct.

6. An application for a certificate of naturalization under section 12 or section 13 of the Act shall include the particulars in the form numbered 4 in the First Schedule hereto.

7. A certificate of naturalization granted under the Act shall be in the form numbered 5 in the First Schedule hereto.

8. (1) The Minister shall enrol for safe custody as of record a duplicate of all certificates of naturalization issued under the Act.

(2) The Minister shall cause proper indexes to be made of certificates enrolled by him as aforesaid, and shall permit every person desirous of so doing to inspect the same and make copies thereof.

(3) A copy of a certificate of naturalization certified to be a true copy by the Under-Secretary of Internal Affairs shall be *prima facie* evidence of that certificate.

## Renunciation and Deprivation of Citizenship

9. A declaration of renunciation of New Zealand citizenship under section 21 of the Act shall be subscribed in duplicate on a printed form supplied by the Under-Secretary of Internal Affairs. This declaration shall include the particulars in the form numbered 6 in the First Schedule hereto.

10. A declaration of renunciation of New Zealand citizenship may be made—

- (a) In New Zealand (excluding the Cook Islands and the Tokelau Islands), before a Magistrate :
- (b) In the Cook Islands, before a Judge or Commissioner of the High Court of the Cook Islands :
- (c) In Western Samoa or the Tokelau Islands, before a Judge or Commissioner of the High Court of Western Samoa:
- (d) In any other place, before a New Zealand overseas representative authorized in that behalf by the Minister. Any such authority may be given to a specified person or to the holder for the time being of a specified office.

11. (1) Both copies of a declaration of renunciation of New Zealand citizenship shall be transmitted to the Department of Internal Affairs at Wellington.

(2) One copy shall be officially noted as having been registered and shall be returned to the declarant, and the other copy shall be filed in the Department.

12. Where the Minister deprives a person of New Zealand citizenship, the order of deprivation shall have effect from such date as the Minister may direct, and thereupon it shall be the duty of that person and of any other person having the certificate in his possession or control to deliver up the certificate of registration or certificate of naturalization for cancellation.

13. (1) Any notice by the Minister under section 23 (6) of the Act shall be given to the holder of the certificate of registration or naturalization or sent to him at his last known address.

(2) Any application for the reference of a case for inquiry and report under section 23 (7) of the Act shall be addressed to the Minister of Internal Affairs at Wellington and shall include an address for service in New Zealand where any document relating to the inquiry can be served upon him.

# OATHS OF ALLEGIANCE

14. Every oath of allegiance taken under or for the purposes of the Act shall be sworn and subscribed in the form numbered 7 in the First Schedule hereto.

15. An oath of allegiance may be taken—

- (a) In New Zealand (excluding the Cook Islands and the Tokelau Islands), before a Magistrate or a Justice of the Peace:
- (b) In the Cook Islands, before a Judge or Commissioner of the High Court of the Cook Islands :
- (c) In Western Samoa or the Tokelau Islands, before a Judge or Commissioner of the High Court of Western Samoa :
- (d) In any other place, before a New Zealand overseas representative authorized in that behalf by the Minister. Any such authority may be given to a specified person or to the holder for the time being of a specified office.

16. If an oath of allegiance is not duly taken within one month after the date on which a certificate of naturalization is granted or, in the case of a certificate granted outside New Zealand, within three months after the date on which it is granted, or within such further time as the Minister may in either case allow, the certificate of naturalization shall not take effect.

17. Every oath of allegiance relating to a certificate of naturalization shall be registered in the Department of Internal Affairs at Wellington.

#### Miscellaneous

18. The forms prescribed by these regulations shall, in their application to persons resident in the Cook Islands, the Tokelau Islands, Western Samoa, and every other New Zealand trust territory, be modified to such extent as may be necessary to comply with the provisions of section 33 of the Act.

19. (1) Fees in accordance with the Second Schedule hereto shall be payable into the Consolidated Fund in respect of the several matters therein mentioned.

(2) In cases of hardship, to be determined by the Minister, or in cases to which section 12 (2) (d) of the Act applies, the Minister may dispense with the fees for naturalization except that payable on lodging notice of intention to apply.
