HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Industries and Commerce Act 1956, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Board of Trade (Wheat and Flour) Regulations 1944, Amendment No. 11, and shall be read together with and deemed part of the Board of Trade (Wheat and Flour) Regulations 1944* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. The principal regulations are hereby amended by inserting, after section 21, the following regulation:

“21A. (1) The Committee is hereby declared to be a statutory Board within the meaning of the Fees and Travelling Allowances Act 1951.

“(2) There may be paid to the members of the Committee from its funds remuneration by way of fees, salary, or allowances and travelling allowances and expenses in accordance with the Fees and Travelling Allowances Act 1951, and the provisions of that Act shall apply accordingly.”

3. (1) Regulation 231 of the principal regulations (as added by regulation 2 of the Board of Trade (Wheat and Flour) Regulations 1944, Amendment No. 8, and amended by the Board of Trade (Wheat and Flour) Regulations, Amendment No. 9) is hereby further amended as follows:

(a) By revoking paragraph (b) of subclause (1), and substituting the following paragraph:

“(b) A further levy computed at the rate of 1d. for every bushel:”:

(b) By omitting from subclause (3) the words “harvested in 1961 or in 1962”.

(2) The Board of Trade (Wheat and Flour) Regulations 1944, Amendment No. 9, are hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 applies the provisions of the Fees and Travelling Allowances Act 1951 to the Wheat Committee.

Regulation 3 increases the levy payable in respect of storage costs from $\frac{1}{2}$ d. a bushel to 1d. a bushel.
