THE BOARD OF TRADE (WHEAT AND FLOUR) REGULATIONS 1944, AMENDMENT NO. 12

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Industries and Commerce Act 1956, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. (1) These regulations may be cited as the Board of Trade (Wheat and Flour) Regulations 1944, Amendment No. 12, and shall be read together with and deemed part of the Board of Trade (Wheat and Flour) Regulations 1944* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.
- 2. The principal regulations are hereby amended by revoking regulations 66 and 67, and substituting the following regulations:
- "66. In respect of every contract for the purchase of wheat by an authorised broker on account of the Committee, the broker shall be entitled to receive from the Committee for every bushel delivered in pursuance of and in conformity with that contract,—
 - "(a) If purchased for sale to flour mills, a commission at the rate of 13d, per bushel; and
 - "(b) If purchased for sale otherwise than to flour mills, a commission at the rate of $1\frac{1}{2}$ d. per bushel.

- "67. In respect of every contract for the sale of wheat by an authorised broker on account of the Committee, the broker shall be entitled to receive from the Committee for every bushel delivered in pursuance of and in conformity with the contract—
 - "(a) If sold to flour mills, a commission at the rate of $1\frac{3}{4}$ d. per bushel;
 - "(b) If sold otherwise than to flour mills, a commission at the rate of 14d. per bushel."
- 3. Subclauses (1) and (2) of regulation 2 of the Board of Trade (Wheat and Flour) Regulations 1944, Amendment No. 7, are hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations fix the rates of brokers' commission in respect of the purchase and sale of wheat on account of the Wheat Committee.
