## THE BOARD OF TRADE (PRICE OF ORANGES) REGULATIONS (NO. 3), 1936.

Enacting authority : His Excellency the Governor-General in Council. Date on which the regulations were made: 14th day of December, 1936.

Date of notification in Gazette: 14th day of December, 1936.
In pursuance and exercise of the power and authority conferred upon him by the Board of Trade Act, 1919, and of every other power and authority enabling him in this behalf, His Excellency the GovernorGeneral of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby, on the recommendation of the Minister of Industries and Commerce, make the following Board of Trade Regulations for the regulation and control of prices of Australian oranges.

## REGULATIONS.

1. These regulations may be cited as the Board of Trade (Price of Oranges) Regulations (No. 3), 1936.
2. These regulations shall come into force on the 12th day of December, 1936.
3. In these regulations, unless the context otherwise requires,-
"Sale by wholesale" means every sale made to any person for the purpose of re-sale :
" Sale by retail" means every sale other than a sale made by wholesale, and includes a sale made to any person for any purpose other than re-sale:
" Oranges " means Australian oranges :
"Export case" means the Australian citrus export case having internal dimensions of 24 in . by $11 \frac{1}{2} \mathrm{in}$. by $11 \frac{1}{2} \mathrm{in}$. :
"Bushel case" means the Australian standard citrus bushel case having internal dimensions of 18 in . by $11 \frac{1}{2} \mathrm{in}$. by $10 \frac{1}{2} \mathrm{in}$.
4. The price of oranges in the localities mentioned in the Schedule hereto when sold by way of sale by wholesale shall not exceed twentytwo shillings and sixpence ( 22 s . 6d.) per export case, and sixteen shillings (16s. 0d.) per bushel case respectively.
5. In respect of all other localities in the Dominion the price of oranges when sold by way of sale by wholesale shall not exceed twentytwo shillings and sixpence ( 22 s . 6 d .) per export case and sixteen shillings (16s. 0d.) per bushel case respectively together with the usual transport charges from the locality mentioned in the Schedule hereto nearest to that other locality as well as such incidental charges (including commission) as may be usual.
6. The price of oranges in the localities mentioned in the Schedule hereto when sold by way of sale by retail shall not exceed a price calculated at the rate of-One shilling (1s.) for four (4) oranges of 126 count per export case ; one shilling (1s.) for five (5) oranges of 150 count per export case ; one shilling (1s.) for six (6) oranges of 176 count per export case ; one shilling (1s.) for seven (7) oranges of 200 and 216 count per export case ; one shilling (1s.) for eight (8) oranges of 252 count per export case; one shilling (1s.) for nine (9) oranges of 288 and over count per export case.
7. The price of oranges in the localities mentioned in the Schedule hereto when sold by way of sale by retail shall not exceed a price calculated at the rate of-One shilling (1s.) for four (4) oranges of 96 count per bushel case ; one shilling (1s.) for five (5) oranges of 112 count per bushel case ; one shilling (1s.) for six (6) oranges of 126 count per bushel case ; one shilling (1s.) for seven (7) oranges of 140 and 154 count per bushel case ; one shilling (1s.) for eight (8) oranges of 168 count per bushel case ; one shilling (1s.) for nine (9) oranges of 182 and over count per bushel case.
8. All oranges for sale or exposed for sale by retail shall be assembled and classified into separate lots by the retailer so selling or exposing them for sale according to the count per case and thereafter every separate lot of such assembled and classified oranges shall be plainly and legibly marked with its relative count per case and the number of oranges which shall be sold for one shilling (1s.).
9. Notwithstanding anything in the preceding clause hereof, it shall be sufficient compliance with the provisions of that clause with respect to assembly and classification into separate lots if-
(a) Oranges whether of 200 or 216 count per export case are assembled and classified as one lot and marked with the figures and words " 200 to 216 count per case".
(b) Oranges whether of 140 or 154 count per bushel case are assembled and classified as one lot and marked with the figures and words " 140 to 154 count per case ".

## SCHEDULE.

The City of Auckland; the Boroughs of Birkenhead, Devonport, Northcote, Takapuna, New Lynn, Newmarket, Mount Albert, Mount Eden, Onehunga, One Tree Hill, and Otahuhu; the Town Districts of Ellerslie, Glen Eden, Henderson, Howick, Manurewa, Papakura, Papatoetoe ; the Road Districts of Mount Roskill and Mount Wellington; and all other places within a radius of twenty-one miles from the Auckland Central Post-office.
The City of Wellington; and the Boroughs of Eastbourne, Lower Hutt, and Petone.
The City of Christchurch ; and the Boroughs of Kaiapoi, Lyttelton, New Brighton, Rangiora, Riccarton, and Sumner.
The City of Dunedin ; and the Boroughs of Green Island, Mosgicl, Port Chalmers, St. Kilda, and West Harbour ; the District of Sawyers Bay ; and the Peninsula County.
