**THE BOARD OF TRADE (ONION) REGULATIONS 1938,  
AMENDMENT NO. 5**

THE RIGHT HON. S. G. HOLLAND PRESIDING IN COUNCIL

PURSUANT to section 26 of the Board of Trade Act, 1919, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council and on the recommendation of the Minister of Industries and Commerce, doth hereby make the following regulations.

---

REGULATIONS

1. (1) These regulations may be cited as the Board of Trade (Onion) Regulations 1938, Amendment No. 5, and shall be read together with and deemed part of the Board of Trade (Onion) Regulations 1938\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. (1) The principal regulations are hereby amended by revoking subclauses (5) and (5A) of regulation 5, as set out in paragraph (a) of subclause (1) of regulation 7 of the Board of Trade (Onion) Regulations 1938, Amendment No. 3, and substituting the following subclause :—

“(5) No person shall consign any graded onions grown in No. 3 District for sale or delivery in No. 1 District or in No. 2 District unless the onions are accompanied by a certificate of confirmation of grade issued in accordance with subclause (7) of this regulation.”

(2) Paragraph (a) of subclause (1) of regulation 7 of the Board of Trade (Onion) Regulations 1938, Amendment No. 3, is hereby revoked.

3. Regulations 8, 9, and 10 of the principal regulations, and regulation 9 of the Board of Trade (Onion) Regulations 1938, Amendment No. 3, are hereby revoked.

4. The Second Schedule to the principal regulations is hereby revoked.

## EXPLANATORY NOTE

[*This note is not part of the regulations, but is intended to indicate their general effect.*]

These regulations made it unnecessary for onion growers and wholesale onion merchants to continue to register or furnish monthly returns of sales, purchases, and stocks. The prohibition of the consignment of onions grown in the South Island for sale or delivery within the counties of Franklin and Horowhenua now appears in the Onion Diseases Regulations (Serial number 1951/39); and the provision in the principal regulations covering this point is therefore revoked.
