THE BROADCASTING REGULATIONS 1977, AMENDMENT NO. 2

ORDER IN COUNCIL

At the Government House at Wellington this 7th day of November 1977

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Broadcasting Act 1976, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Broadcasting Regulations 1977, Amendment No. 2, and shall be read together with and deemed part of the Broadcasting Regulations 1977* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Broadcasting Rules Committee—(1) Regulation 3 of the principal regulations is hereby amended by revoking subclause (9), and substituting the following subclauses:

"(9) All rules, variations, amendments, and interpretations of the rules relating to television made by the Committee shall, if agreed upon unanimously by those present and endorsed by the Corporation, be binding on all holders of television warrants.

" (9_A) All rules, variations, amendments, and interpretations of the rules relating to radio broadcasting made by the Committee shall, if agreed upon unanimously by those present and endorsed by the Corporation and the Association, be binding on all holders of radio broadcasting warrants. In any case in which agreement between the Corporation and the Association cannot be reached in respect of rules relating to radio broadcasting, the provisions of section 26 (5) of the Act shall apply."

*S.R. 1977/11 Amendment No. 1: S.R. 1977/236 (2) Regulation 3 (10) of the principal regulations is hereby amended by omitting the words "subclause (9)", and substituting the words "subclauses (9) and (9A)".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

The effect of these regulations is that the rules in relation to programme standards for television will require to be made by the Broadcasting Rules Committee and endorsed by the Broadcasting Corporation of New Zealand, and will no longer require the endorsement of the Independent Broadcasters Association Incorporated.

The regulations re-enact former provisions that the rules in relation to programme standards for radio broadcasting are to be made by the Committee and endorsed by the Corporation and the Association, and that section 26 (5) of the Broadcasting Act 1976 is to apply in the event of the Corporation and the Association being unable to agree.
