### ORDER IN COUNCIL

PURSUANT to the Biosecurity Act 1993, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Biosecurity (Costs) Regulations 1993.

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

**2. Interpretation**—In these regulations, unless the context otherwise requires,—

“The Act” means the Biosecurity Act 1993:

“Animal” means anything that is—

- (a) A living stage of an organism that is a member of the animal kingdom; or
- (b) The carcase, egg, or semen of an amphibian, bird, fish, mammal, or reptile:

“Animal material”,—

- (a) Subject to paragraph (b) of this definition, means any organic material that is derived from, or is an excretion or secretion of, an animal; but
- (b) Does not include any such material if an inspector is satisfied that it has been so treated that it is free of any unwanted organism:

“Consignment” means the goods listed on or covered by a single bill of lading or airway bill:

“The First Schedule” means the First Schedule to these regulations:

“Nursery stock” means any plant material (including a whole plant) capable of being used for propagation, other than—

- (a) A vegetable intended for consumption;
- (b) A fruit or seed;
- (c) The dormant bulb, corm, rhizome, or tuber, of any ornamental plant:

“Plant” means any member of the plant kingdom:

“Plant material”,—

- (a) Subject to paragraph (b) of this definition, means any organic material that is, or is derived from, a plant; but
- (b) Does not include any such material if an inspector is satisfied that it—

- (i) Is free of any unwanted organism; and
- (ii) Is incapable or carrying any unwanted organisms; and

- (iii) Is not viable:
- “Produce” means any plant material customarily or from time to time eaten by human beings; and—
- (a) Subject to paragraph (b) of this definition, includes any inedible plant material attached to, formerly attached to, contained within, or forming part of a consignment that includes, any produce; but
- (b) Does not include any plant material that has been deep-frozen, dehydrated, dried, or pickled (in alcohol, brine, or vinegar):
- “Sample”, in relation to any quantity of product,—
- (a) In the case of a product comprising discrete units, means one or more units of the product; or
- (b) In the case of a product not comprising discrete units, means one or more units of the product,—
- selected at random for that quantity without regard to quality:
- “Sample size” means the number of units of a product or, as the case may be, the length, area, volume, mass, or quantity, of a product constituting a sample:
- “The Second Schedule” means the Second Schedule to these regulations:
- “Shipping container” includes any standardised device used to contain or hold goods while being loaded for carriage by air or sea, carried by air or sea, and unloaded after carriage by air or sea:
- “The Third Schedule” means the Third Schedule to these regulations:
- “Unit”, in relation to produce of any kind or description, means—
- (a) A such single item of such produce; or
- (b) A bunch, cluster, or plant of such produce,—
- depending on how such produce normally occurs:
- “Unit of product”, in relation to any product inspected to determine—
- (a) Whether it is defective; or
- (b) The extent (if any) to which it is defective,—
- means the unit, units, length, area, volume, mass, quantity, or component, of the product so inspected (whether or not it is the same as the unit production, purchase, shipment, or supply, of the product); and where the product in its entirety is inspected, means the product in its entirety:
- “Usual hours”, in any place, means the hours between 8 a.m. and 5 p.m. on any day other than Saturday, Sunday, New Year’s Day, the day after New Year’s Day, Waitangi Day, Good Friday, Easter Monday, Anzac Day, the Sovereign’s Birthday, Labour Day, Christmas Day, Boxing Day, or the day observed in that place as Anniversary Day:
- “Veterinary inspector” means an inspector who is for the time being registered as a veterinary surgeon under section 16 of the Veterinary Surgeons Act 1956.

**3. Calculation of costs at hourly rates**—(1) Subject to subclause (2) of this regulation, any costs required by these regulations to be calculated on the basis of a rate per hour spent by any person in doing any thing shall be calculated by adding—

- (a) That rate; and

- (b) The product of—
    - (i) One quarter of the rate; and
    - (ii) The number (if any) of complete periods of 15 minutes in excess of 1 hour spent by that person in doing that thing; and
  - (c) Where any time in excess of 1 hour spent by that person in doing that thing was not an exact multiple of 15 minutes, one quarter of that rate.
- (2) Any costs required by these regulations to be calculated on the basis of a rate per hour in excess of any specified period spent by any person in doing any thing shall be calculated by adding—
- (a) The product of—
    - (i) One quarter of the rate; and
    - (ii) The number (if any) of complete periods of 15 minutes in excess of that period spent by that person in doing that thing; and
  - (b) Where any time in excess of that period spent by that person in doing that thing was not an exact multiple of 15 minutes, one quarter of that rate.

*Costs Payable as Specific Amounts*

**4. Animal clearances**—The person who imports an animal or a consignment of animals that are cleared without going to a transitional facility shall pay to the Director-General the costs first specified in the First Schedule.

**5. Treatment of individual risk goods**—A passenger who imports any item of risk goods in the passenger's baggage, unaccompanied baggage, mail, or personal effects shall pay to the Director-General in respect of the treatment of that item the costs secondly specified in the First Schedule.

**6. Inspection of used vehicles**—The importer of any used motor vehicle or wheeled tractor shall pay to the Director-General in respect of the inspection of that vehicle or tractor for the purpose of ascertaining whether or not it should be cleared the costs thirdly specified in the First Schedule.

**7. Inspection of containers**—The importer of any container shall pay to the Director-General in respect of the inspection of that container for the purpose of ascertaining whether or not it should be cleared the costs fourthly specified in the First Schedule.

**8. Inspection of consignments of baggage or effects**—The importer of an unaccompanied consignment of baggage, personal effects, or household effects (or a consignment of effects of 2 or all of those kinds) shall pay to the Director-General in respect of its inspection for the purpose of ascertaining whether or not it should be cleared—

- (a) The costs fifthly specified in the First Schedule, where the consignment is cleared, or clearance is refused, after inspection of documentation only;
- (b) The costs sixthly specified in the First Schedule, where—
  - (i) There has been full inspection; and
  - (ii) The volume of the consignment is 0.5m<sup>3</sup> or less;
- (c) The costs seventhly specified in the First Schedule, where—

- (i) There has been a “item only” inspection; and
  - (ii) The volume of the consignment is more than 0.5m<sup>3</sup>;
- (d) The costs eighthly specified in the First Schedule, where—
- (i) There has been a full inspection; and
  - (ii) The volume of the consignment is more than 0.5m<sup>3</sup> but less than an entire shipping container;
- (e) The costs ninthly specified in the First Schedule, where—
- (i) There has been a full inspection; and
  - (ii) The consignment comprises an entire shipping container.

**9. Inspection of fish meal**—The importer of any consignment of fish meal shall pay to the Director-General in respect of the inspection of that consignment for the purpose of ascertaining whether or not it should be cleared the costs tenthly specified in the First Schedule.

**10. Inspection of other animal material**—The importer of any consignment of animal material (other than fish meal) shall pay to the Director-General in respect of the inspection of that consignment for the purpose of ascertaining whether or not it should be cleared—

- (a) The costs eleventhly specified in the First Schedule, in the case of trade samples of animal materials that are not animal remedies, biological products, or pesticides;
- (b) The costs twelfthly specified in the First Schedule, in any other case.

**11. Inspection of nursery stock and fresh-cut flowers**—The importer of any consignment of nursery stock or fresh-cut flowers shall pay to the Director-General in respect of the inspection of that consignment for the purpose of ascertaining whether or not it should be cleared the costs thirteenthly specified in the First Schedule.

**12. Inspection of fresh fruit and vegetables**—The importer of any consignment of fresh fruit or vegetables (other than nursery stock) shall pay to the Director-General in respect of the inspection of that consignment for the purpose of ascertaining whether or not it should be cleared—

- (a) The costs fourteenthly specified in the First Schedule; and
- (b) For every 150 units or part thereof of fruit or vegetables in excess of 450 contained in the consignment, the further costs fifteenthly specified in the First Schedule.

**13. Inspection of seeds (other than bulk grain)**—The importer of any consignment of seeds (other than bulk grain) shall pay to the Director-General in respect of the inspection of that consignment for the purpose of ascertaining whether or not it should be cleared the costs sixteenthly specified in the First Schedule.

**14. Inspection of stored produce**—The importer of any consignment of stored produce (other than frozen produce) shall pay to the Director-General in respect of the inspection of that consignment for the purpose of ascertaining whether or not it should be cleared the costs seventeenthly specified in the First Schedule.

**15. Inspection of other plant material**—The importer of any consignment of plant material (other than nursery stock, fresh-cut flowers, fresh fruit or vegetables, seeds, or stored produce (other than frozen

produce)) shall pay to the Director-General in respect of the inspection of that consignment for the purpose of ascertaining whether or not it should be cleared the costs eighteenthly specified in the First Schedule.

**16. Destruction of risk goods**—The importer of any risk goods destroyed by an inspector shall pay to the Director-General in respect of the destruction of every 0.5m<sup>3</sup> or part thereof of those goods the costs nineteenthly specified in the First Schedule.

**17. Inspection of documents**—The importer of a consignment of goods shall pay to the Director-General in respect of the inspection by an inspector of documents relating to that consignment the costs twentiethly specified in the First Schedule.

**18. Surveillance of discharge of cargo**—The importer of any goods shall pay to the Director-General in respect of each visit for the surveillance of the discharge of those goods for the purpose of ascertaining whether or not it should be cleared—

- (a) The costs twenty-firstly specified in the First Schedule, where the surveillance occurs entirely during usual hours; and
- (b) The costs twenty-secondly specified in the First Schedule, in every other case.

**19. Identification of organisms**—The importer of any goods that are or contain an organism that has to be identified by an inspector before the inspector can determine whether or not the goods should be cleared shall pay to the Director-General in respect of the identification of that organism—

- (a) The actual and reasonable costs of all tests, examinations, and treatments of those goods that were reasonably necessary to enable the identification of the organism; and
- (b) Either—
  - (i) The costs twenty-thirdly specified in the First Schedule, where the identification occurs entirely during usual hours; or
  - (ii) The costs twenty-fourthly specified in the First Schedule, in every other case.

**20. Import health permits**—The applicant for an import health permit shall pay to the Director-General on application for it—

- (a) In the case of a permit for—
  - (i) Camelids, cattle, deer, goats, horses, sheep, or swine, or the eggs or semen of any of them; or
  - (ii) Animals of any kind, or the eggs or semen of any animals of any kind, imported for the purposes of any zoological garden; or
  - (iii) Poultry hatching eggs,—the costs twenty-fifthly specified in the First Schedule:
- (b) In the case of a permit for birds, cats, dogs, or the eggs (other than poultry hatching eggs), embryos, or semen of any of them, the costs twenty-sixthly specified in the First Schedule:
- (c) In the case of a permit for any—
  - (i) Nursery stock, plants, plant material, or seeds; or
  - (ii) Invertebrate animals, micro-organisms, or viruses; or

- (iii) Goods other than animals or animal products,—  
not required to be quarantined, the costs twenty-seventhly specified in the First Schedule:
- (d) In the case of a permit for any nursery stock, plants, plant material, or seeds, required to be quarantined, the costs twenty-eighthly specified in the First Schedule:
- (e) In the case of any other goods, the costs twenty-ninthly specified in the First Schedule.

**21. Variations of import health permits**—The holder of an import health permit shall pay to the Director-General on application for a variation of it—

- (a) In the case of a permit for goods of a kind specified in any of paragraphs (a), (b), or (e) of regulation 20 of these regulations, the costs thirtiethly specified in the First Schedule:
- (b) In any other case, the costs thirty-firstly specified in the First Schedule.

**22. Compliance auditing of transitional facilities other than quarantine facilities**—The operator of a transitional facility other than a quarantine facility shall pay annually to the Director-General for compliance auditing of that facility the costs thirty-secondly specified in the First Schedule.

**23. Animals held in quarantine**—The importer of an animal held in a quarantine facility shall pay to the Director-General, for every 1.0m<sup>2</sup> (or part thereof) of space occupied every day (or part thereof) by the animal the costs thirty-thirdly specified in the First Schedule.

**24. Plants growing in quarantine**—The importer of a cultivar or clone of any plant growing and being monitored in a quarantine facility shall pay to the Director-General,—

- (a) In the case of a plant that is—
  - (i) A citrus plant from a country where citrus canker is known to occur; or
  - (ii) A *prunus* plant from a country where plum pox is known to occur,—  
the costs thirty-fourthly specified in the First Schedule:
- (b) Subject to paragraph (a) of this regulation,—
  - (i) In the case of a plant not requiring specific tests for disease, the costs thirty-fifthly specified in the First Schedule:
  - (ii) In the case of a plant requiring tests for disease using only the technique of attempting transfer of pathogens to herbaceous indicator plants, the costs thirty-sixthly specified in the First Schedule:
  - (iii) In the case of a plant requiring tests for disease using a technique other than that of attempting transfer of pathogens to herbaceous indicator plants, the costs thirty-seventhly specified in the First Schedule.

*Costs Payable at Hourly Rates*

**25. Inspection of animals in transitional facility other than quarantine facility**—The importer of an animal held in a transitional facility other than a quarantine facility shall pay to the Director-General,—

- (a) For the examination of the animal during usual hours by a veterinary inspector, costs calculated at the hourly rate first specified in the Second Schedule for each such inspector involved:
- (b) For the examination of the animal at any other time by a veterinary inspector, costs calculated at the hourly rate secondly specified in the Second Schedule for each such inspector involved:
- (c) For the examination of the animal during usual hours by an inspector other than a veterinary inspector, costs calculated at the hourly rate thirdly specified in the Second Schedule for each such inspector involved:
- (d) For the examination of the animal at any other time by an inspector other than a veterinary inspector, costs calculated at the hourly rate fourthly specified in the Second Schedule for each such inspector involved.

**26. Inspection of animals not intended for clearance**—The owner of an animal that is on board any craft within New Zealand territory but is not intended to be cleared shall pay to the Director-General,—

- (a) For the examination of the animal during usual hours by a veterinary inspector, costs calculated at the hourly rate fifthly specified in the Second Schedule for each such inspector involved:
- (b) For the examination of the animal at any other time by a veterinary inspector, costs calculated at the hourly rate sixthly specified in the Second Schedule for each such inspector involved:
- (c) For the examination of the animal during usual hours by an inspector other than a veterinary inspector, costs calculated at the hourly rate seventhly specified in the Second Schedule for each such inspector involved:
- (d) For the examination of the animal at any other time by an inspector other than a veterinary inspector, costs calculated at the hourly rate eighthly specified in the Second Schedule for each such inspector involved.

**27. Inspection of conveyances, machinery, etc.**—There shall be paid to the Director-General—

- (a) By the importer of any used vehicle parts or used tyres, in respect of their inspection by an inspector for the purpose of ascertaining whether or not they should be cleared, costs calculated at the hourly rate ninthly specified in the Second Schedule for each inspector involved:
- (b) By the importer of any used tracked vehicle or used agricultural machinery (other than motorcycles or wheeled tractors), in respect of their inspection by an inspector for the purpose of ascertaining whether or not they should be cleared, costs calculated at the hourly rate tenthly specified in the Second Schedule for each inspector involved:
- (c) By the importer of any goods of a kind specified in paragraph (a) or paragraph (b) of this regulation or in regulation 6 of these regulations, in respect of any second or subsequent inspection by an inspector for the purpose of ascertaining whether or not they should be cleared, costs calculated at the hourly rate eleventhly specified in the Second Schedule for each inspector involved.



**28. Inspection of consignments of baggage or effects**—The importer of an unaccompanied consignment of baggage, personal effects, or household effects (or a consignment of effects of 2 or all of those kinds) shall pay to the Director-General in respect of any inspection of that consignment (being an inspection lasting more than 30 minutes) for the purpose of ascertaining whether or not it should be cleared, in addition to the costs prescribed by regulation 8 of these regulations, costs calculated, by reference to the time in excess of 30 minutes, at the hourly rate twelfthly specified in the Second Schedule for each inspector involved.

**29. Inspection of bulk grain**—The importer of any shipment of grain imported in bulk shall pay to the Director-General in respect of the inspection of that shipment for the purpose of ascertaining whether or not it should be cleared the costs calculated at the hourly rate thirteenthly specified in the Second Schedule for each inspector involved.

**30. Inspection of nursery stock and fresh-cut flowers**—The importer of any consignment of nursery stock or fresh-cut flowers shall pay to the Director-General in respect of any inspection of that consignment (being an inspection lasting more than 1 hour) for the purpose of ascertaining whether or not it should be cleared, in addition to the costs prescribed by regulation 11 of these regulations, costs calculated, by reference to the time in excess of 1 hour, at the hourly rate fourteenthly specified in the Second Schedule for each inspector involved.

**31. Inspection of seeds (other than bulk grain)**—The importer of any consignment of seeds (other than bulk grain) shall pay to the Director-General in respect of the inspection of that consignment (being an inspection lasting more than 1 hour) for the purpose of ascertaining whether or not it should be cleared, in addition to the costs prescribed by regulation 13 of these regulations, costs calculated, by reference to the time in excess of 1 hour, at the hourly rate fifteenthly specified in the Second Schedule for each inspector involved.

**32. Disposition of goods**—The importer of non-complying goods that are reshipped or otherwise disposed of shall pay to the Director-General in respect of the supervision of their disposition from the time of detection to the time of disposal costs calculated at the hourly rate sixteenthly specified in the Second Schedule for each inspector involved.

**33. Inspection of documents**—The importer of a consignment of goods shall pay to the Director-General in respect of the inspection by an inspector of documents relating to that consignment (being an inspection lasting more than 30 minutes) for the purpose of ascertaining whether or not it should be cleared, in addition to the costs prescribed by regulation 17 of these regulations, costs calculated, by reference to the time in excess of 30 minutes, at the hourly rate seventeenthly specified in the Second Schedule for each inspector involved.

**34. Inspection of transitional facilities other than quarantine facilities**—The operator of a transitional facility other than a quarantine facility shall pay to the Director-General in respect of the inspection by an inspector of the facility for the purpose of ascertaining whether or not it should be approved, costs calculated at the hourly rate eighteenthly specified in the Second Schedule for each inspector involved.

**35. Examinations of animals in quarantine facilities**—The importer of an animal held in a quarantine facility shall pay to the Director-General in respect of examination of the animal by an inspector for the purpose of ascertaining whether or not it should be cleared, costs calculated—

- (a) In the case of an examination carried out by a veterinary inspector, at the hourly rate nineteenthly specified in the Second Schedule for each such inspector involved:
- (b) In the case of an examination carried out by an inspector other than a veterinary inspector, at the hourly rate twentiethly specified in the Second Schedule for each such inspector involved.

**36. Waiting time**—Where an inspector arrives at an inspection site at the designated time to inspect any goods and the goods are not available for inspection, the person who is required to pay the costs of the inspection shall also pay to the Director-General in respect of the delay costs calculated, by reference to the length of the delay, at the hourly rate twenty-firstly specified in the Second Schedule for each inspector involved.

**37. Miscellaneous inspections out of hours**—Where—

- (a) An inspector makes, out of hours, an inspection in respect of which costs are prescribed by these regulations; and
- (b) Those costs are prescribed by reference to an hourly rate; and
- (c) These regulations do not prescribe that rate as being a rate for an out of hours inspection,—

the person required to pay those costs shall also pay to the Director-General costs calculated at the hourly rate twenty-secondly specified in the Second Schedule for each inspector involved.

#### *Other Matters*

**38. Treatment of risk goods**—The importer of any risk goods treated before clearance shall pay to the Director-General the actual and reasonable costs to the Director-General of the treatment concerned; and shall bear the costs (if any) of packaging, storing, forwarding, and returning the goods before and after treatment.

**39. Approval and supervision of private operators of transitional facilities**—The private operator of a transitional facility shall pay to the Director-General the actual and reasonable costs to the Director-General of approving or supervising the operator.

**40. Travel costs**—(1) Where any activity by an inspector in respect of which any person is required by these regulations to pay costs requires the inspector to leave the inspector's base, the person shall pay to the Director-General, in addition to any other costs, costs calculated at the rate per kilometre specified in the Third Schedule on the distance (or shared proportion of the distance) travelled (whether from that base, to that base, or between any intermediate points).

(2) Where any activity by an inspector in respect of which any person is required by these regulations to pay costs requires the inspector to leave the inspector's base, the person shall pay to the Director-General, in addition to any other costs, costs calculated at the hourly rate twenty-thirdly specified in the Second Schedule on the time (or shared proportion of the time) spent by the inspector away from the base.

**41. Waiver of costs**—Where satisfied that—

- (a) Because the work actually done does not justify the payment (or full payment) of the costs concerned; or
- (b) Because of special circumstances applicable to the particular case,—the Director-General may waive, wholly or in part, the payment of any costs required by these regulations to be paid; and, where all or part of those costs have already been paid, may refund to the person who paid it all of the amount paid.

**42. Consequential revocations**—The following regulations are hereby consequentially revoked:

- (a) The Introduction and Quarantine of Plants Regulations 1973:
- (b) The Animals (Quarantine and Import Inspection Fees) Regulations 1987:
- (c) The Introduction and Quarantine of Plants Regulations 1973, Amendment No. 4:
- (d) The Animals (Import Permit Fees) Regulations 1988.
