ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR GENERAL IN COUNCIL

PURSUANT to section 137 of the Building Societies Act 1965, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Building Societies Regulations 1967, Amendment No. 3, and shall be read together with and deemed part of the Building Societies Regulations 1967* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 14th day after the date of their notification in the *Gazette*.

2. New scale of fees substituted—The principal regulations are hereby amended by revoking the Third Schedule, and substituting the Third Schedule set out in the Schedule to these regulations.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations increase the fees payable for various matters under the Building Societies Act 1965.

The regulations also provide that where an alteration or rescission of rules is registered under section 19 of the Building Societies Act 1965 a separate fee is to be payable for registration for each rule altered or rescinded. The Building Societies Regulations 1967 provided that one fee was payable in respect of a registration of an alteration or rescission of rules (irrespective of the number of rules affected). A separate registration fee applies where an entire set of rules replaces an existing set of rules.

Fees, additional to those set out in the Building Societies Regulations 1967, are prescribed in respect of-

(a) The receiving of a notice of a change of office of director, manager, or secretary of a society under section 88 (1) of the Act:

(b) The receiving of copies of accounts and reports under section 97 (2) of the Act:

(c) The receiving of an annual return made under section 103 of the Act.

Where a society is designated under section 63 of the Act as a society with which trustees may invest trust funds, higher fees are prescribed in relation to the receiving of copies of accounts and reports and the receiving of annual returns.
