PURSUANT to section 62 of the Corporations (Investigation and Management) Act 1989, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title—This order may be cited as the Corporations (Investigation and Management) Order (No. 2) 1990.

2. Termination of statutory management of certain corporations—It is hereby declared that—

- (a) The subsidiaries of Chase New Zealand Property Group Limited specified in the Schedule to this order; and
 - (b) Phar Lap Investments Limited—
- shall cease to be subject to statutory management on the 24th day of September 1990.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order declares that certain companies in the Chase group of companies shall cease to be subject to statutory management on 24 September 1990. The companies are—

- (a) Certain subsidiaries of Chase New Zealand Property Group Limited; and
- (b) Phar Lap Investments Limited.

The effect of the order is that, in accordance with section 62 (3) of the Corporations (Investigation and Management) Act 1989,—

- (a) Each of those companies ceases to be subject to statutory management on that date; and
- (b) The appointment of the statutory managers terminates in respect of those companies.
