



THE CUSTOMS (EXCISE) AMENDMENT ORDER 1988

ORDER IN COUNCIL

At Wellington this 5th day of December 1988

PURSUANT to section 118CA of the Customs Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Customs (Excise) Amendment Order 1988.

(2) This order shall come into force on the 1st day of January 1989.

2. Third Schedule amended—The Third Schedule to the Customs Act 1966 is hereby amended by revoking so much of the Third Schedule as relates to items 99.50.10k, 99.70.00c, and 99.80.00j, and substituting the items and rates of duty specified in the Schedule to this order.

3. Consequential revocations—The Customs Tariff (Harmonised System) Amendment Order 1987 (S.R. 1987/316) is hereby amended by revoking so much of the Third Schedule as relates to items 99.50.10k, 99.70.00c, and 99.80.00j.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

With the introduction of the Harmonised Tariff and the new Third Schedule of the Customs Act 1966 an anomaly was created relating to the application of the Alcoholic Liquor Advisory Council Act 1975 levy. This order corrects that anomaly together with other minor drafting changes.
