PURSUANT to section 8 of the Civil Aviation Amendment Act 1991, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Civil Aviation Regulations 1953, Amendment No. 37, and shall be read together with and deemed part of the Civil Aviation Regulations 1953* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the

date of their notification in the Gazette.

- 2. Revocation—Regulation 34D of the principal regulations is hereby revoked.
- **3. Carriage of dangerous goods**—Regulation 31 of the principal regulations (as substituted by regulation 2 of the Civil Aviation Regulations 1953, Amendment No. 30) is hereby amended by revoking subclauses (1) to (4) and (7) to (9).

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the 28th day after the date of their notification in the Gazette, amend the Civil Aviation Regulations 1953.

Regulation 2 revokes regulation 340 of the principal regulations (which relates to flight time limitations in air transport operations). This matter is now covered by Part 121, Subpart K and Part 123, Subpart K of the Civil Aviation Rules.

Regulation 3 amends regulation 31 of the principal regulations by revoking subclauses (1) to (4) and (7) to (9) (which relate to the labelling, handling, and inspection of dangerous goods carried by air). These matters are now covered by Part 92 of the Civil Aviation Rules.
