# THE CATTLE BRUCELLOSIS AND TUBERCULOSIS CONTROL REGULATIONS 1971, AMENDMENT NO. 5

## ORDER IN COUNCIL

At the Government House at Wellington this 21st day of November 1977

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Animals Act 1967, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. Title—These regulations may be cited as the Cattle Brucellosis and Tuberculosis Control Regulations 1971, Amendment No. 5, and shall be read together with and deemed part of the Cattle Brucellosis and Tuberculosis Control Regulations 1971\* (hereinafter referred to as the principal regulations).

2. Test costs—(1) The principal regulations are hereby amended by revoking the First Schedule (as substituted by regulation 2 of the Cattle Brucellosis and Tuberculosis Control Regulations 1971, Amendment No. 2 and amended by regulation 2 of the Cattle Brucellosis and Tuberculosis Control Regulations 1971, Amendment No. 3 and regulation 7 of the Cattle Brucellosis and Tuberculosis Control Regulations 1971, Amendment No. 4), and substituting the First Schedule set out in the Schedule to these regulations.

(2) Regulation 12 (2) of the principal regulations is hereby amended by omitting the word "mileage", and substituting the word "motor vehicle".

# NEW FIRST SCHEDULE TO PRINCIPAL REGULATIONS

#### **"FIRST SCHEDULE**

Regs. 7, 12

### Fees

Brucellosis Vaccinations-

The fee for brucellosis vaccinations carried out by an Inspector shall be 25c per animal with a minimum of \$2.00 where fewer than 8 animals are being vaccinated at the same time.

In addition to the vaccination fee a motor vehicle allowance of 13.05c per kilometre shall be payable for a reasonable distance certified by an Inspector as travelled to carry out a brucellosis vaccination in terms of these regulations.

The fee and motor vehicle allowance shall in each case be payable by the owner of the animal.

Tuberculin Tests-

The testing fee payable to a Tuberculin Testing Officer, being a person who is not an Inspector but who is a registered veterinary surgeon appointed by the Minister to carry out tuberculin tests for the purposes of section 53 of the Animals Act 1967, shall be:

(a) Dairy Cattle—

Sub-caudal Intradermal Tests-

96c for each of the first 10 animals.

32c for each further animal from 11 to 70.

30c for each further animal from 71 to 140.

27c for each further animal in excess of 140.

The minimum fee payable shall be \$9.60 per herd.

(b) Beef Cattle—

Sub-caudal Intradermal Tests-

The minimum fee payable shall be \$6.80 per herd. (c) Motor Vehicle Allowance—

In addition to the test fee, a motor vehicle allowance of 13.05c per kilometre shall be payable for a reasonable distance certified by a Tuberculin Testing Officer as travelled to carry out a tuberculin test in terms of these regulations.

#### Brucellosis Tests-

The testing fee payable to a registered veterinary surgeon, being a person who is not an Inspector but who is appointed as a Brucellosis Testing Officer by the Minister to carry out Brucellosis tests for the purposes of section 53 of the Animals Act 1967, shall be:

(b) Motor Vehicle Allowance-

In addition to the test fee, a motor vehicle allowance of 13.05 cents per kilometre shall be payable for a reasonable distance certified by a Brucellosis Testing Officer as travelled to carry out a brucellosis test in terms of these regulations:

Provided that a separate motor vehicle allowance for a brucellosis test shall not be payable where this test is carried out on the same visit as a tuberculin test under these regulations."

### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations substitute a revised schedule of fees in the principal regulations. The motor vehicle allowance for brucellosis vaccinations, tuberculin tests and brucellosis tests, and the fees for tuberculin tests and brucellosis tests, are increased.

Issued under the authority of the Regulations Act 1936. Date of notification in *Gazette*: 24 November 1977. These regulations are administered in the Ministry of Agriculture and Fisheries.
