

THE CATTLE BRUCELLOSIS AND TUBERCULOSIS CONTROL REGULATIONS 1971, AMENDMENT NO. 7

ORDER IN COUNCIL

At the Government House at Wellington this 27th day of November 1978

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Animals Act 1967, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Cattle Brucellosis and Tuberculosis Control Regulations 1971, Amendment No. 7, and shall be read together with and deemed part of the Cattle Brucellosis and Tuberculosis Control Regulations 1971* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Test costs—The First Schedule to the principal regulations (as substituted by regulation 2 (1) of the Cattle Brucellosis and Tuberculosis Control Regulations 1971, Amendment No. 5) is hereby amended by omitting from paragraph (c) of the item relating to tuberculin tests and from paragraph (b) of the item relating to brucellosis tests the words "of 13.05 cents per kilometre", and substituting in each case the words "at a rate set from time to time by the Minister".

3. Inspector may seize and destroy reactors in certain circumstances—The principal regulations are hereby amended by inserting, after regulation 14, the following regulation:

"14a. (1) Where the Director-General directs pursuant to section 53 (4) of the Animals Act 1967 that an animal be slaughtered within a specified time and the animal is not so slaughtered, an Inspector may, after giving to the owner or person in charge of the animal not less than 14 days notice of his intention to do so, seize the animal and slaughter it or cause it to be slaughtered.

"(2) Every Inspector shall keep a record of every animal so seized and slaughtered by him, with in each case the description, brands, and marks thereof and the locality where the animal was slaughtered.

"(3) Any amount received from the sale of the carcass of any animal so slaughtered, less the costs incurred in the seizure and slaughter of the animal and the sale of the carcass, shall be paid to the owner of the animal."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 amends the First Schedule to the principal regulations (which prescribes fees payable to veterinary surgeons for tuberculin and brucellosis tests) to provide that the rate of motor vehicle allowance so payable shall be set by the Minister of Agriculture and Fisheries from time to time (instead of being specified in the schedule).

Regulation 3 inserts a new regulation 14A in the principal regulations which provides that, where a person fails to slaughter an animal in accordance with a direction given under section 53 (4) of the Animals Act 1967, an Inspector may seize the animal and slaughter it.
