THE CATTLE BRUCELLOSIS AND TUBERCULOSIS CONTROL REGULATIONS 1971, AMENDMENT NO. 8

ORDER IN COUNCIL

At the Government House at Wellington this 21st day of May 1979

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Animals Act 1967, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Cattle Brucellosis and Tuberculosis Control Regulations 1971, Amendment No. 8, and shall be read together with and deemed part of the Cattle Brucellosis and Tuberculosis Control Regulations 1971* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Vaccination costs—The principal regulations are hereby amended by revoking the First Schedule (as substituted by regulation 2 (1) of the Cattle Brucellosis and Tuberculosis Regulations 1971, Amendment No. 5), and substituting the First Schedule set out in the Schedule to these regulations.

3. Payment of test costs—The principal regulations are hereby amended by revoking regulation 12, and substituting the following regulation:

"12. Payment of test costs by Crown—Where any animal is subjected to a test for brucellosis or tuberculosis for the purposes of section 53 of the Animals Act 1967, the cost of the test shall be borne by the Crown and paid out of money appropriated by Parliament for that purpose."

4. Revocation of regulations relating to vaccination fees and test costs-The following regulations are hereby consequentially revoked:

- (a) The Cattle Brucellosis and Tuberculosis Control Regulations 1971, Amendment No. 5:
- (b) Regulation 2 of the Cattle Brucellosis and Tuberculosis Control Regulations 1971, Amendment No. 7.

SCHEDULE

NEW FIRST SCHEDULE TO PRINCIPAL REGULATIONS **"FIRST SCHEDULE**

Reg. 7

Fee For Brucellosis Vaccinations

The fee for brucellosis vaccinations carried out by an Inspector shall be 25c per animal with a minimum of \$2.00 where fewer than 8 animals are being vaccinated at the same time.

In addition to the vaccination fee a motor vehicle allowance of 13.05c per kilometre shall be payable for a reasonable distance certified by an Inspector as travelled to carry out a brucellosis vaccination in terms of these regulations.

The fee and motor vehicle allowance shall in each case be payable by the owner of the animal."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations revoke the provisions that allow brucellosis and tuberculosis test costs to be recovered from the owners of the cattle.

In future, the Crown will bear the cost in all cases. The amount of the fees will no longer be prescribed, but will be fixed by negotiation with the veterinary surgeons concerned.
